

SERVICE CONTRACT – (93679-04)
WOODBURY COUNTY JUVENILE DETENTION CENTER
AMENDMENT TWO

This Amendment is entered into by and between the Administrative Office of the Courts & Probation (hereinafter “Probation”) and Woodbury County Juvenile Detention Center (hereinafter “Detention Center”).

Purpose: to increase the service rate effective July 1, 2023.

The Contract for Detention Services between the parties dated January 26, 2021 is hereby amended as follows:

Section B. PAYMENT, ARTICLE 2. subsection b. is hereby amended to read:

- b. In consideration of the Detention Center’s provision of the Services described herein, effective July 1, 2023, Probation shall pay detention costs to Detention Center in the sum of \$200.00 (two-hundred dollars) per Juvenile for each day.
 - i. Probation will begin to incur costs on the date of admission and for each subsequent night the juvenile is detained. Probation shall not be billed for the last day of Service.
 - ii. The parties agree that over the remaining life of the agreement, any future rate increases as determined by Probation and appropriated by Nebraska Legislature may be presumptively agreed to and authorized by Detention Center upon written notice to Detention Center and its Governing Board, so long as no other term or condition of this agreement is consequently, contingently, or otherwise altered.

All other terms and conditions remain in full force and effect.



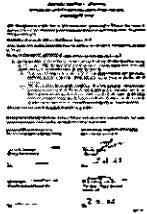
