

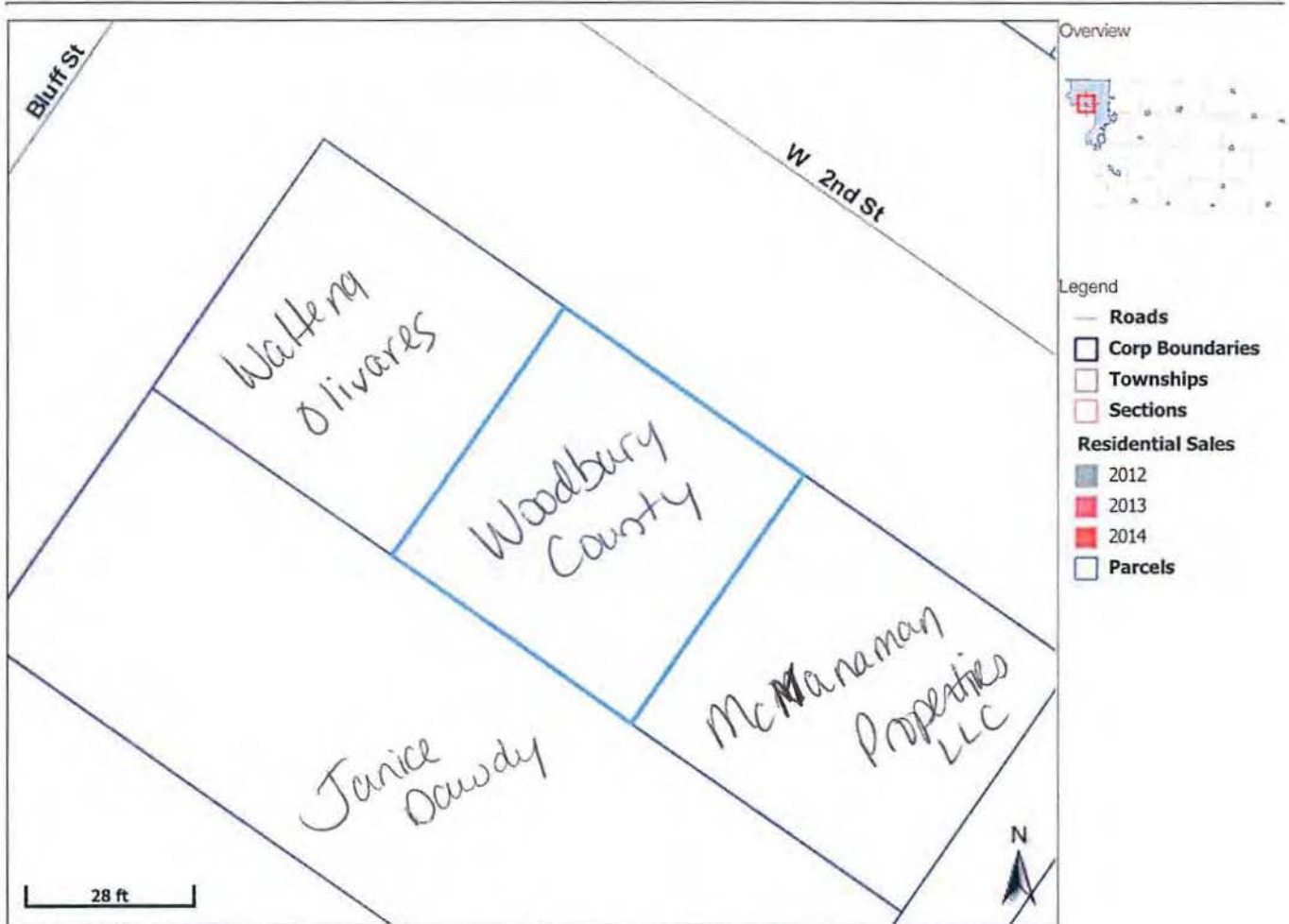

Other possible maintenance to be included with this project depending on results of the field survey include, cleaning the drainage ditch, clearing of trees and brush, and cleaning existing drainage pipe at the railroad. 

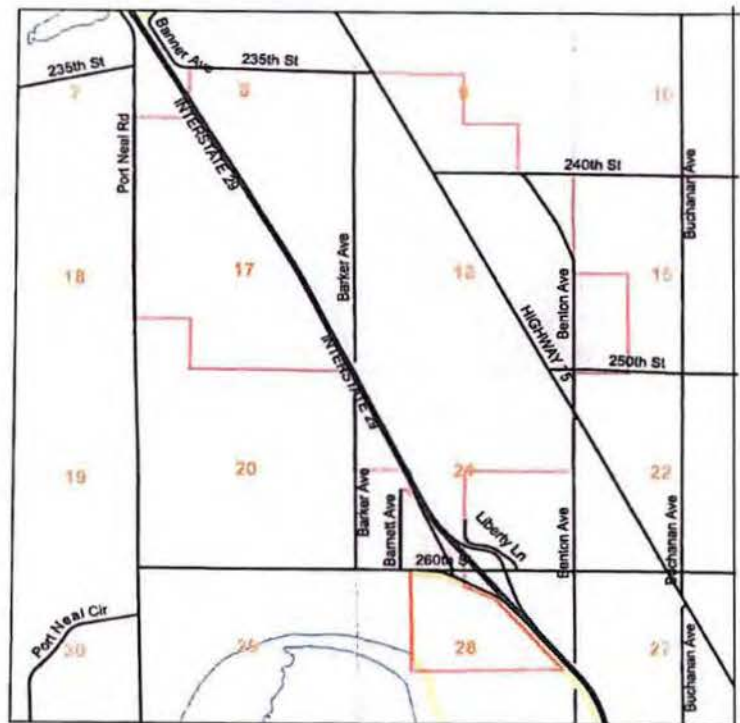

GENERAL UNDERSTANDING

Veenstra & Kimm, Inc.'s understanding is that The Woodbury County Board of Supervisors, acting as trustee for the Orton Slough Drainage District, is seeking an engineering consultant to provide design services for repair improvements to the Orton Slough Drainage District.

The Orton Slough Drainage District, established in 1919, encompasses 2,255 acres south of Sioux City and Sergeant Bluff, Iowa. The district is split by Interstate 29 and includes a main ditch and drainage structures that drain to a 30" intake, which feeds a 20" butted concrete pipe, which outlets into Brown's Lake.

Veenstra & Kimm, Inc. understands that a recent review of the existing tile line resulted in finding several broken tile sections and two damaged intakes. We will perform a field and condition survey to evaluate the drainage system to identify any additional sections of tile and/or intakes needing repair. Our survey will include the main ditch from the railroad structure near the 250th Street and Old Highway 75 intersection west to the main intake. During the survey the ditch will be checked to see if it needs to be cleaned, excavated, or cleared of trees and brush. Pipes through the railroad will also be inspected to see if they require cleaning. This maintenance work will be included in the bid plans as necessary.

Veenstra & Kimm, Inc. will provide plans and documents sufficient to allow the County to apply for Corps of Engineers and Iowa Department of Natural Resources (IDNR) permits. Final plans will be prepared by April 1, 2015 for a letting on or about April 30, 2015 and for construction of the project repairs.

If the preliminary design process requires modeling of water quantity to determine sizes of facilities and water quality impacts of the proposal on Brown's Lake, this work would be performed under an amendment to the original contract. Although the United States Environmental Protection Agency's Storm Water Management Model (SWMM) would be adequate for quantity calculations, SWMM's water quality functions are more applicable to an urban environment. United States Department of Agriculture's model would be used instead, if it is necessary to model the existing situation, as well as the proposed situation. Based on the modeling, sizes will be adjusted and design modifications will be recommended and evaluated. Any modeling required for this project is assumed to be outside the scope of the project as indicated by the RFP, and Veenstra & Kimm, Inc. would request an amendment to the original contract.

Services requires by Veenstra & Kimm, Inc, to engineer, analyze, or evaluate water quantity and quality control facilities for this drainage district would be considered additional work and an amendment to the original contract amount would be required.

The County will provide areas of need for additional drainage and survey data as needed. Veenstra & Kimm, Inc will prepare final plans and bid documents to the trustees for letting purposes.



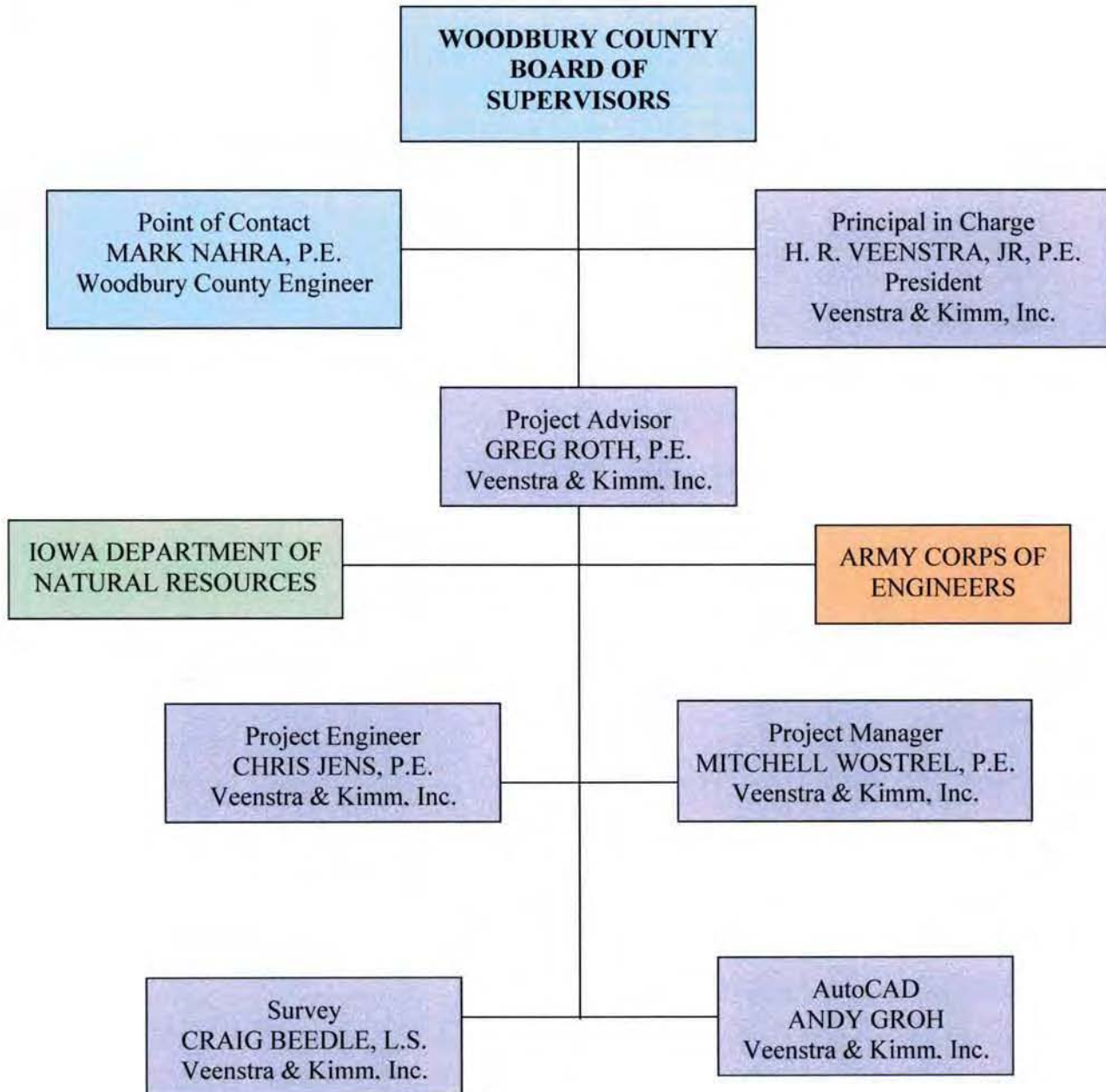

I-29 Water Main Crossing Harbor Drive to South Lewis Blvd Reconstruction - Sioux City, Iowa

We are in the third phase of an overall project to bring water from the new water plant, located on Harbor Drive, into the city of Sioux City. The City currently has a 16" water main that runs southerly along Port Neal Road and dead-ends at the intersection of Port Neal Road and 260th Street in Woodbury County. The city has entered into a utility reimbursement agreement, No. U-2013-15767, with the IDOT that includes funding the replacement of the 16" system with a 36" to provide water to the city.

This new 36" water main begins at Harbor Drive and runs easterly to the connection with a 24" reducer near South Lewis Blvd. The constructed water main will require a boring under I29 just north of the bridge over the UPRR and there are three bore crossings with UPRR that require 51" steel casings. This project also includes layout and design implementation of dual 2" PVC conduits for future fiber optic lines that will be offset from the water main a nominal 8 feet.

Extensive coordination has been required with Union Pacific Railroad (UPRR), for multiple crossings and coordination with the Iowa DOT was mandated for the I29 crossing. Coordination with the City of Sergeant Bluff was also a must with respect to temporary closures along Lewis Blvd.



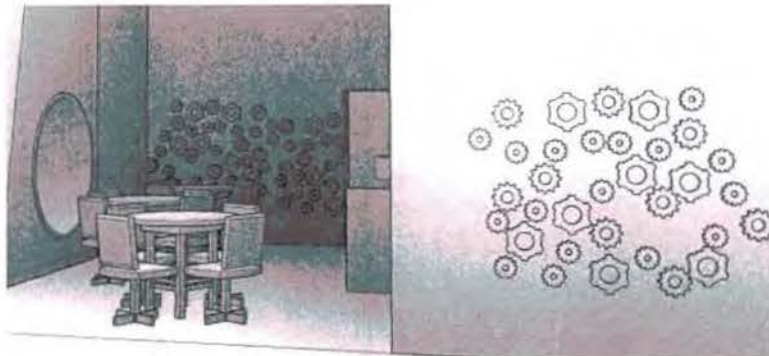

We are currently detaining seven juveniles from the BIA, one from Dakota County and one from Sioux County, IA.
