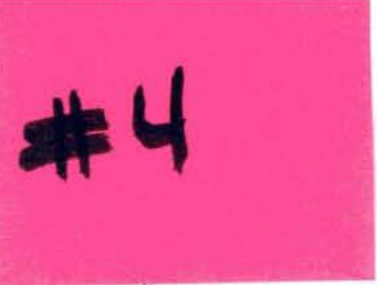

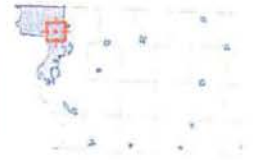

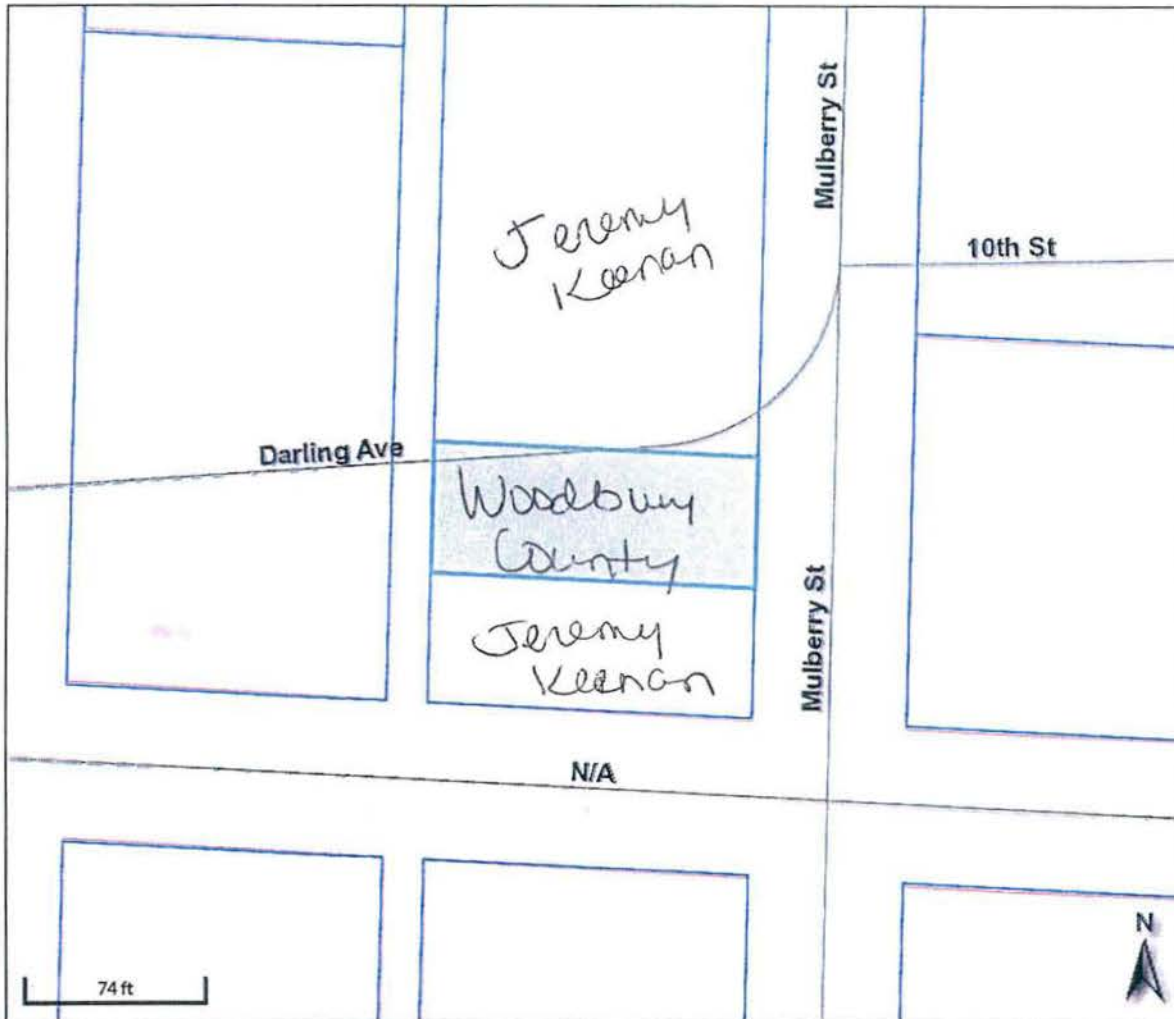

EXECUTIVE SUMMARY: This is an exciting opportunity to hear from our Veterans Affairs Commission and get to know all five members. We will have refreshments (all are welcomed), a presentation to a Veteran who assisted having the flags made for Veterans Court, and a short presentation from the Commission.

BACKGROUND: The Veterans Affairs Commission has three new members and exists to serve Woodbury County Veterans. They have some exciting updates and will share them with the Board.

FINANCIAL IMPACT: None

RECOMMENDATION: Receive information

ACTION REQUIRED: Gain awareness, raise the profile of this important group, and express appreciation.

What does the Woodbury County Commission of Veteran Affairs do?

The most important thing we do is to improve the lives of our Veterans by obtaining and maintaining Federal VA Benefits, including compensation, pension and medical benefits.

FY 2003: \$24,201,000.00 paid to Woodbury County residents. (1st year of Directors employ)

FY 2011: \$34,823,000.00 paid to Woodbury County residents. (1st year of Directorship)

FY 2014: \$49,033,000.00 paid to Woodbury County residents. (Most recent data)

In the 13 years Director Dempster has been filing claims for Woodbury County Residents, VA dollars paid to our taxpayers have more than doubled. Since moving to the Triview location, business has tripled and held at the increased level. There is no way to sustain this growth without increased staff, which is impossible at our current location. Our current caseload is about 4000 clients with only 2 County Veteran Service Officers, Director Dempster and Kelly Hansen.

The following is a summary of some of the things we do on a daily basis:

Federal Programs

Service-Connected Compensation and Dependency and Indemnity Compensation (DIC)

- Apply for compensation following medical or mental injury during service; we have seen a significant increase in PTSD claims every year for at least the past 7 years
- A Veteran can file a claim for any condition any time after discharge. (We do claims for service-connection for WWII Veterans.)
- Some claims are denied and can involve multiple appeals that can span several years.
- As conditions worsen, we apply for increases in compensation.
- DIC is compensation for survivors of Veterans whose death was caused by a service-related condition

Non-Service Connected Disability Pension and Survivor's Pension

- Needs based pensions for war-era Veterans and their dependents
- For eligibility, we must determine total net worth, all income sources and out-of-pocket medical expenses
- If eligible, we must submit application and all supporting materials.
- Benefit must be maintained and may increase when claimant becomes homebound and/or enters a care facility

Healthcare – using the VA medical healthcare system

- Eligibility, enrollment, annual reporting, scheduling, transportation, billing, social work and more

Other Federal Work

- Funeral/death benefits, obtaining military discharges, personnel records, service medical records, adding/removing dependents, home loans, education, life insurance, funeral/death benefits, homeless programs, and other programs

State Programs

- Property: Military Property Tax Exemption, Disabled Veterans Tax Credit and Homeownership
- Lifetime Hunting/Fishing License for service-connected Veterans/POWs through DNR
- Veteran License Plates (currently one at no charge)
- Iowa Trust Fund Applications – emergency financial assistance, submitted through our office
- Pre-applications for burial at the Iowa Veterans Cemetery, as well as arrangements
- Veterans status for Drivers License must be verified by our office
- Iowa Veterans Home – Applications submitted through our office; verify Iowa Veterans status
- Obtaining allocation to improve our service to Veterans and reporting usage back to the state of Iowa
- On a monthly basis, we obtain the names of new patients of each nursing home, assisted living or other facility, who may be eligible for pension benefits. We mail out information to the Veteran, dependent or point of contact. Upon contact, we screen for eligibility.
- Yellow ribbon events, employment programs, Home Base Iowa and other programs

County Programs

- Sponsor DAV van program to co-ordinate transportation to and from Sioux Falls VA Hospital, to include:
 - Recruitment and submittals to maintain volunteer drivers
 - Annual appreciation dinner for volunteer drivers
 - Set up monthly schedule, according to driver availability
 - Set departure time and passengers for 3 trips per week
- Annual Veterans Day Ceremony on November 11th at 11:00 a.m.
- Outreach events to educate about our office and Veteran benefits. These include benefit fairs, annual stand down, Woodbury County Fair, Clay County Fair and others
- Emergency assistance is a very small part of what we do, but does involve a significant amount of time for our clerk to receive applications, follow up, submit claims and associated paperwork, quarterly reports (all of which is virtually paperless at this point)

Staff also takes direction from the Commission on a variety of issues, especially emergency assistance.

Director Dempster is a member of the Veterans Treatment Court, which adds to the workload.

Constant updates to our database as Veterans/dependents move away or pass away.

CVSOs need constant education and research to stay updated on many changes to all programs. We must obtain Continuing Education Credits through the National Association of County Veteran Service Officers in order to continue accreditation. These schools are held at state (Des Moines) and national levels.

CVSOs maintain working relationships with federal, state and local agencies to provide all of the above.

In addition to all programs and related issues, when a Veteran visits our office, the CVSOs do their best to assist the Veteran with any issue they may have, including many things that have nothing to do with any of the above. So, in short, we try to be everything to every Veteran.

WORDING FOR AGENDA ITEM: Preliminary review of County Policy for Repair Requests for Drainage Districts

EXECUTIVE SUMMARY: The attached policies are for board review and discussion. The attached policy is recommended by the county engineer to provide a framework for dealing with future drainage district repair and maintenance requests. The Board of Supervisors is charged by the Code of Iowa with responsibility for administering drainage districts within the county. In the past, maintenance requests have been handled by the secondary road department. In order to better keep the board informed of work within drainage districts, we are proposing to run all requests through the board. Additionally the policy proposes that the Board will conduct inspections upon the county receiving a federal disaster declaration to allow the Board to secure any funding assistance for repairs to drainage districts that result from extreme storm events.

BACKGROUND: The secondary road department is reviewing all operating policies in cooperation with the Board of Supervisors.

FINANCIAL IMPACT: These policies will affect future work within drainage districts and subsequent levies for such work. This work is outside the county budget process and does not affect the overall county budget.

RECOMMENDATION: No recommendation at this time. The policy is presented for discussion and questions only.

Drainage District Maintenance and Repair Policy

Date: October 20, 2015

The Woodbury County Board of Supervisors is responsible for eleven drainage districts for which the Board serves as trustees. These districts are as follows:

- 1) Anthon Central
- 2) Bennett-McDonald
- 3) Maple River
- 4) Orton Slough
- 5) Smithland
- 6) Smokey Hollow
- 7) Upper Wolf Creek
- 8) Weber Creek
- 9) Wolf Creek
- 10) Wolf Creek Pump District
 - a) Wolf Creek Pump District subdistrict 2
 - b) Wolf Creek Pump District subdistrict 3
- 11) Bennett McDonald Smithland Special Project

The attached policy provides procedures for addressing maintenance and repairs within drainage districts that will provide earlier notice of repair costs to landowners and the opportunity for more transparency, landowner input, and, if requested or required, hearings prior to undertaking maintenance work in the districts. The attached policy also has provisions to more quickly identify damage to drainage district improvements after severe weather events that result in a federal disaster declaration for the county to assure that any aid in repair of county drainage improvements can be identified and obtained on behalf of county drainage districts.

Drainage District Maintenance Requests:

- 1) Requests for maintenance work within drainage districts which are managed by the Woodbury County Board of Supervisors as trustees shall be filed on a form available at the Board of Supervisors office. The requests shall be signed by the complainant and contact information provided for setting up an appointment to view the maintenance issue. Requests for work will be considered at the next scheduled board agenda at which time the Board shall go into session as trustees of the drainage district in question.

- 2) The Board will assign either the county engineer, if the secondary road department work load allows, or a drainage engineering consultant to review the site with the complainant. The county engineer or drainage engineering consultant, either of which is hereinafter referred to as the drainage engineer, will contact the complainant and review the location that is the subject of the maintenance request. Photographs of the damage will be taken. A survey of the damage will be done if deemed necessary by the drainage engineer. A report with recommendations for repair work will be filed with the Board of Supervisors for their consideration. Costs for consulting engineers to perform the work of the drainage engineer will be billed to the drainage district in which the complaint is made as part of that district's annual assessment.
- 3) The Board, acting as trustees for the district, will review the drainage engineer's report. If the Board determines work is needed, the Board will instruct the drainage engineer to prepare a scope of work. The drainage engineer will develop a scope of work to restore the drainage ditch as required by 468.126.
- 4) The scope of work for the repair will be prepared in sufficient detail for contractors to review the site and prepare quotations for the repair. The repair work may be done on an hourly basis by the contractor, by a "not to exceed" cost quotation, or by a combination of payment and measurement methods as determined appropriate by the drainage engineer depending upon the type and nature of the needed repair work.
- 5) The drainage engineer will seek two to three quotations from qualified contractors for all work with an engineer's estimate of less than \$50,000. The Board may publish a legal notice requesting bids or quotations if they choose to do so. Quotations will be due from contractors on a date to be set by the drainage project engineer. Quotations will be brought to the Board of Supervisors for approval. The board of supervisors, acting as trustees, may, at their option, schedule a hearing prior to awarding the quotations. The quote will be awarded and paid by the drainage district.
- 6) Work will be given general supervision by the appointed drainage engineer. Upon completion of the work, the drainage engineer shall present a certification of completion of work to the county engineer's office. The certification of completion shall specify pay items and payment due to the contractor. The county engineer's office will prepare a claim for board of supervisors' approval.
- 7) If the drainage engineer's estimate or the quotation for the work exceeds \$50,000, the Board of Supervisors will schedule a hearing as provided in Section 468.126 of the Code of Iowa.

Severe Storm Events -Damage Inspections:

Drainage districts, like other county infrastructure, are subject to damage during extreme storm events. Like other public improvements, damaged drainage districts may be eligible for FEMA

assistance with cleanup and repair of storm damage and removal of debris within the improvement.

In the event that a severe storm event occurs resulting in a disaster declaration for the county, the Board of Supervisors will hire a consulting engineer to inspect all board managed drainage district improvements to determine whether damage has been incurred within any district. The cost of the consulting engineer will be distributed among the county board managed districts in proportion to their size. The consulting engineer will prepare a report that will be presented to the county emergency manager for submittal to FEMA and IHSEMD staff for consideration for disaster aid for completion of necessary repairs. The Board, at their option, may extend the services of the drainage engineering consultant as needed to coordinate with FEMA and IHSEMD for evaluation of the damage and needed repairs.

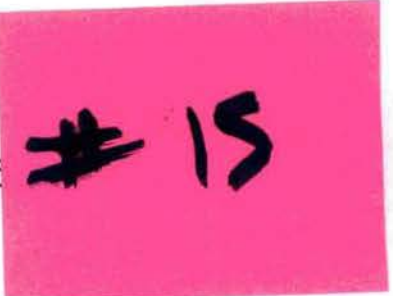

WORDING FOR AGENDA ITEM: Economic Development for Rural Communities from LOST funds

EXECUTIVE SUMMARY: Economic development in rural Woodbury County needs tools that can better be utilized by our communities. We have an obligation to give the very best tools to our communities because this funding mechanism was created by the Legislature to take sales tax revenue and further invest it in economic development.

BACKGROUND: As Woodbury County moves on to give communities the tools that they need to grow, the commitment on behalf of the Board is to economic development. Such funding proposals and mechanisms should have as a prerequisite a community plan that the county will ultimately pay for.

FINANCIAL IMPACT: To be determined

RECOMMENDATION: That a working group of 3 individuals from the County and 5 private citizens be compromised, the Chairman, Board of Supervisors liaison to Economic Development, and the Economic Development Director with a citizen group. This citizen group would comprise a representative from the Taxpayers' Research Conference, the Editor of The Record (the newspaper serving rural Woodbury County), the Editor of the Sergeant Bluff Advocate, the Mayor of Sergeant Bluff, and the Mayor of Merville. The goal would be to craft a proposal for the Board approval for truly making a difference out in rural Woodbury County. Such a program should be widespread, available to all communities, and take meetings of each rural community's input (per the prior or upcoming approved comprehensive plan) to ensure that dollars benefit entire communities. Part of the portfolio for such a plan could also include leveraging the Economic Development Department's ability to help procure grants (state and federal funding), nuisance abatement, feasibility of water/sewer and infrastructure needs as well as access to capital for startups or expansion.

Not only would this group help to re-energize and make a difference for sound, results-based economic development but also this group could help in a critical new process of recommendations for the RFP concerning entities that will conduct long-range planning for each community. Having gone through the process recently, both the Merville and the Sergeant Bluff mayor could provide very helpful input on what they feel may be a good process.

ACTION REQUIRED: I move that the working group of the aforesaid individuals begin meeting in order to make recommendations to the Board.

EXECUTIVE SUMMARY: Is it time to put a citizen/stakeholder group together to establish a 5, 10 even 20 year plan for building use? Questions loom in the background

- What is the time line for Prairie Hills? What is the plan for creating space for jail population, if there is no Prairie Hills? In the past there have been strong feelings about the closure of Prairie Hills and placing those individuals within the general jail population. There has been a citizens group that has studied this issue and provided input. There has been an ongoing complaint from Jail staff that the jail is overcrowded. What is the overall long range plan and the cost?
- Is there interest in making the BOS meeting room more professional?
- Is storage of machines in office space the best use of offices?
- What can be reconfigured or redesigned to take us into the future. Nothing, Everything? Cost?
- The list goes on.....

It appears that information is being gathered, like the Baker Group, like the individuals working on a plan for Prairie Hills, like the recent building services move, like the parking study, but these efforts appear disjointed and lack full disclosure until the entire board is expected to hurry up and vote on the move, the relocation, the redesign. We are piloting a rating scale for CIP projects; will that help in the overall planning of space? Goals and benchmarks and costs should be developed and shared publically in a thoughtful, timely manner. One good

example of long range planning of space was the CIP project submitted by District Health. Because of the urgency of the LED lighting this project is in jeopardy.

BACKGROUND During last week's CIP agenda item there was information shared that Prairie Hills CIP was on hold. Some information was given that "individuals" were working on a plan. What is the timeline for Prairie Hills? There are also rumors flying around that offices are moving. In 2014 TRC and Supervisor Smith advocated for a space study. To date, the public or entire BOS have not been made aware of such a plan or who is working in small committees to redesign space use.

EXECUTIVE SUMMARY. While there may be a philosophical difference of opinion as to the merits of the loan program, there are several glaring reasons as to why the decision to end the rural loan program needs to be rescinded.

A commitment to fund this program for \$400,000 was made through resolution during the 2014-2015 budget cycle. Supervisors had ample opportunity to express concerns about this program during that process and NOT ONE concern was voiced by any supervisor. This is a tool that was placed in the toolbox of Woodbury County's Economic Development director and it is simply unfair to remove it midyear.

- The current Board made a verbal commitment to the citizens of Woodbury County to be transparent and to allow 1-2 board meetings to discuss an item prior to action. What happened to this commitment? Accusations of illegal deliberation have surfaced.
- There was not ample notice given to loan applicants that this program was to be gutted. Three applicants were in the preliminary stages and one applicant was near the end of the process. The applicants were not given time to craft an exit plan from the loan process and to develop other financing strategies/options. Possible litigation could result from the County's failure to uphold commitments.

- During the Cushing town hall meeting and the Board meeting on 9/29/2015 disparaging comments were made by some Board members about the individuals that voiced their opposition to end the loan program. No person should ever be publically chastised for exercising their right as a citizen to disagree with the leaders that have been elected to serve them. How customer friendly is that?
- Also alarming, are the accusations that loan promises have been made all over the county. Where is the evidence to support such a claim? Isn't the process that was set up (by a previous board) just being followed?
- This loan program is taking hold. While using the statistic of 4 loans in 5 years is true, it is also misleading. This loan program has been promoted and massaged for approximately 1 ½ years.
- Since the abrupt end to the Investing in Woodbury County Loan program, the Board has received a letter signed by all but one of the rural mayors asking us to reinstate the loan program. TRC has asked us to revisit the issue and has taken issue with the manner in which this action occurred. I have received many inquiries and complaints about ending this program.
- In 1988 our rural citizens voted for local option sales tax. Our rural citizens have asked the BOS to restore this fund and are willing to work with the Supervisors to evaluate this program and look at different uses for LOST funds . It is a reasonable approach and should be honored.

BACKGROUND: This program was abruptly discontinued. Ample rural feedback indicates this is a program with widespread support. BOS has received a letter from rural mayors asking the Board to reinstate the loan program. The BOS has received an official statement from Tax Research that requests the Board reconsider termination of the Investing in Woodbury County loan program.

FINANCIAL IMPACT:

RECOMMENDATION: Consider discussion and action at the 10/13/15 Board meeting to rescind the decision to end the Invest in Woodbury County Loan Program. Develop a stakeholders committee to evaluate the loan program and investigate other options for LOST funds.

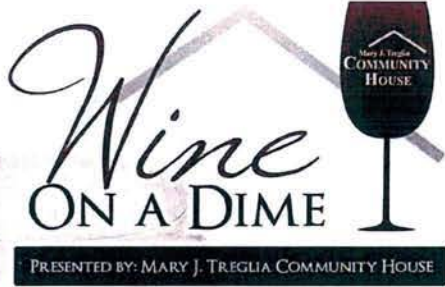

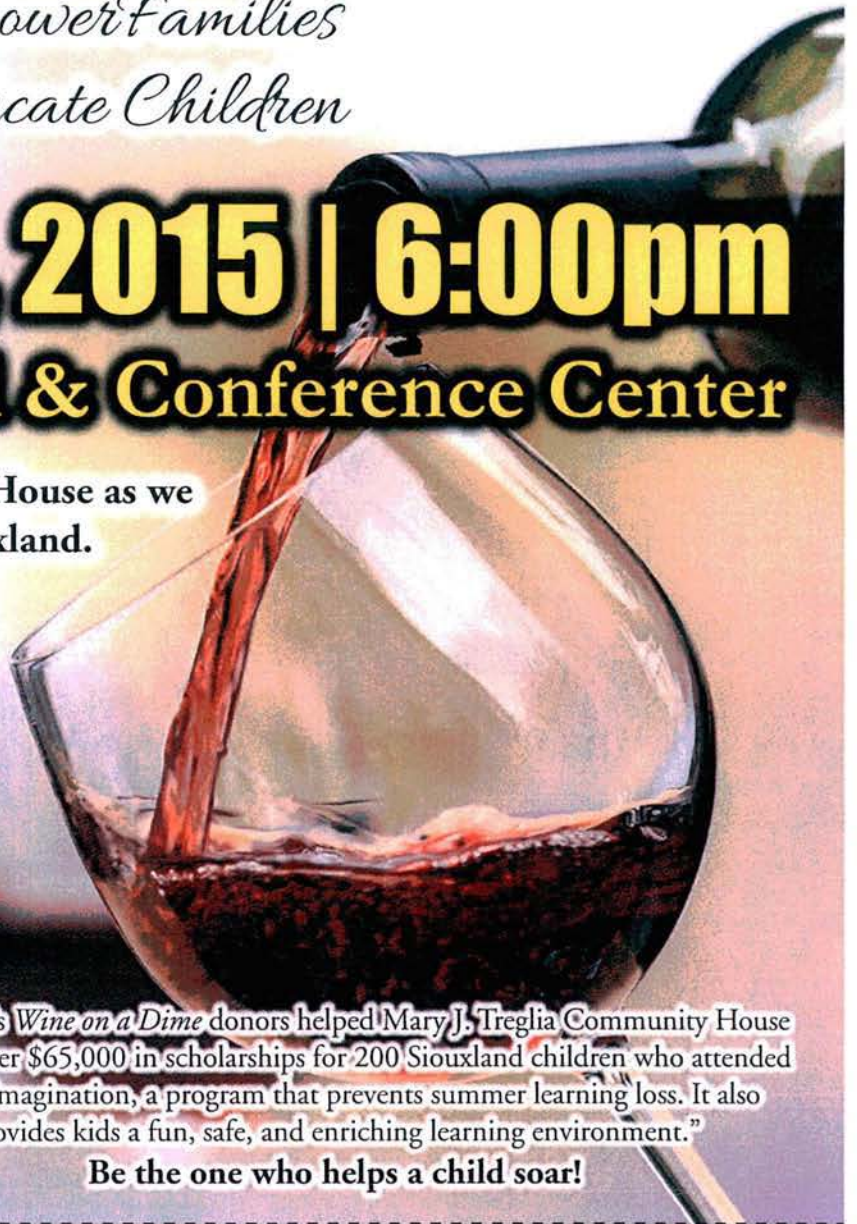

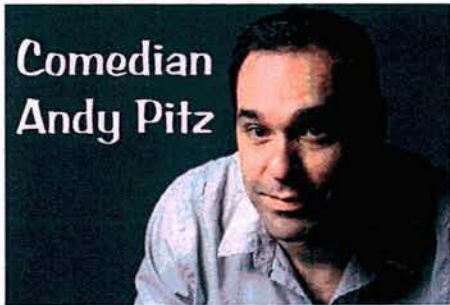
