BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE WOODBURY COUNTY LAW ENFORCEMENT CENTER AUTHORITY:

Section 1. That the following bid for the construction of certain public improvements described in general as the Woodbury County Law Enforcement Center, described in the plans and specifications heretofore adopted by this Authority on May 11, 2021, be and is hereby accepted, the same being the lowest responsive, responsible bid received for such work, as follows:

Contractor: Hausmann Construction, Inc. of Lincoln, Nebraska
Amount of bid: \$58,390,000.00
Portion of project: All construction work

Section 2. That the Chairperson and Secretary are hereby directed to execute the contract with the contractor for the construction of the public improvements, such contract not to be binding on the Authority until approved by this Board of Commissioners.
