## ITEM R1. Discuss Employee Law Enforcement Contract

Dan explained that Tyler Knight has asked to be released from his contract and that he has been offered a position with Crawford County Conservation Board. Reviewing the contract showed that the employee is required to reimburse the county not only for academy costs, but also for salaries and benefits paid while at the academy, which would be a total of \$27,638.34. Dan stated that he didn't realize that the salaries and benefits reimbursement was part of the Woodbury County contract. Crawford County is willing to reimburse up to \$10,000 of the academy costs which total \$10,137.52.

Dan asked the board to release Tyler Knight and waive salaries and benefits reimbursement, so he can move on to Crawford County. He stated that Tyler's interests lie more in the natural resources area, rather than park management and law enforcement.

The board discussed in length the pros and cons of waiving that portion of the contract and thereby setting a precedence for future contracts. It was also understood that keeping an employee who doesn't want to stay is not a good situation for either party, especially if he is not comfortable with the law enforcement duties.
