WHEREAS, the following action is now considered to be in the best interests of the Authority.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF WOODBURY COUNTY LAW ENFORCEMENT CENTER AUTHORITY:

WHEREAS, the Woodbury County Law Enforcement Center Authority (the "Authority"), is a body corporate, organized and existing under and by virtue of Iowa Code Section 346.27, and any successor legal authority thereto; and

WHEREAS, the County has now adopted a resolution adopting Bylaws and Rules of Procedure included therein for the Authority; and

WHEREAS, Iowa Code Section 346.27 requires that the Authority be directed and governed by a Board of Commissioners of three members that have been appointed by the governing body of their respective incorporating unit; and

WHEREAS, Iowa Code Section 346.27 and the Bylaws further provide that the Board of Commissioners shall designate one of their number as Chairperson, one as Secretary, and one as Treasurer; and

WHEREAS, the Authority hereby intends to appoint the initial officers of the Authority to serve as provided in the Bylaws; and

WHEREAS, the following action is now considered to be in the best interests of the Authority.

Whereupon, the following Resolution was duly adopted:

WHEREAS, the Woodbury County Law Enforcement Center Authority, proposes to contract indebtedness and authorize and issue Woodbury County Law Enforcement Facilities Revenue Bonds (the "Revenue Bonds") to provide funds to pay costs of the joint county and city building authority project for the purpose of exercising any and all powers afforded under Iowa Code Section 346.27, or any successor legal authority thereto, including, but not limited to: acquiring, demolishing, improving, enlarging, equipping, furnishing, repairing, maintaining, and operating a public building and acquiring and preparing any necessary site for the joint use of the incorporating units; and

RESOLUTION CALLING A SPECIAL COUNTY ELECTION

WHEREAS, Sections 346.27 of the Code of Iowa, provides that before the Board of Commissioners may institute proceedings for the authorization of the Revenue Bonds, it shall call a special election to vote upon the proposition in accordance with the provisions of the Code; and

WHEREAS, neither the proposal for the issuance of the Revenue Bonds hereinafter set forth, nor any other proposal incorporating any portion of it, has or will have been submitted to the registered voters of the county for a period of more than six months prior to the date of election hereinafter provided; and

WHEREAS, the "Sioux City Journal" is a legal newspaper, printed wholly in the English language, as defined by Section 618.3 of the Code of Iowa, and is published in the county and of general circulation therein; and

WHEREAS, the following action is now considered to be in the best interest of the Authority.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE WOODBURY COUNTY LAW ENFORCEMENT CENTER AUTHORITY:

Section 1. That there is hereby called a special election on Tuesday, the 3rd day of March, 2020, at which election there shall be submitted to the registered voters of the county the following question, to-wit:

"Shall the Woodbury County Law Enforcement Center Authority, be authorized to issue its Law Enforcement Center Facilities Revenue Bonds in an amount not exceeding the amount of \$50,300,000 for the purpose of designing, constructing, equipping, and furnishing a law enforcement center including the acquisition of land for such purposes for the joint use of Woodbury County and the City of Sioux City?"

Section 2. That the voting place or places for the election, and the hours the polls shall be opened and closed shall be as set out in the Notice of Election, such notice to be prepared and approved by the County Commissioner of Elections.

Section 3. That the form of ballot to be used at the election shall be of the type authorized by the Code of Iowa that will permit the use of electronic counters and will be in substantially the form set forth in the Notice of Election. That, if more than one public measure shall be submitted to the electors at the time of the election, all such measures shall be printed upon one ballot.

Section 4. That the Election Board for the voting precinct or precincts shall be appointed by the County Commissioner of Elections, not less than 15 days before the date of said election.

Section 5. That the Auditor of Woodbury County, Iowa, being the County Commissioner of Elections, is hereby directed to publish the Notice of Election as required by Iowa Code Sen 49.53, said publication to occur once in the "Sioux City Journal", being a legal newspaper, printed wholly in the English language, as defined by Section 618.3 of the Code of Iowa, published in said County and of general circulation therein, the publication to be not less than four clear days nor more than twenty days prior to the date of the election.

Section 6. That in addition to the above Notice of Election required by Iowa Code Section 49.53, the Secretary is hereby directed to cause the Notice of Election attached hereto as Exhibit "A" to be published in the "Sioux City Journal", being a legal newspaper, printing wholly in the English language, as defined by Section 618.3 of the Code of Iowa, published in said County and of general circulation therein, the publications to occur for two consecutive

weeks prior the election, each publication to be not less than four clear days nor more than twenty days prior to the date of the election.

Section 7. That the County Commissioner of Elections shall cause to be prepared all such ballots and election registers and other supplies as may be necessary for the proper and legal conduct of said election.

Section 8. That the Secretary is hereby directed to file a certified copy of this Resolution in the office of the County Commissioner of Elections, which filing shall also constitute the "written notice" to the County Commissioner of Elections of the election date required to be given by the governing body under the provisions of Chapter 47 of the Code of Iowa.
