Whereupon, the Resolution was duly adopted as follows:

RESOLUTION ORDERING CONSTRUCTION OF THE WOODBURY COUNTY LAW ENFORCEMENT CENTER, AND FIXING A DATE FOR HEARING THEREON

WHEREAS, it is deemed advisable and necessary to construct certain public improvements described in general as the Woodbury County Law Enforcement Center; and

WHEREAS, on April 20, 2021, the Authority fixed a date for receiving bids for the public improvements for May 20, 2021, before 2:30 P.M., and approved and directed the posting of a notice to bidders once in a relevant contractor plan room service with statewide circulation and a relevant construction lead generating service with statewide circulation and on an internet site sponsored by either the Authority or a statewide association that represents the Authority, to occur not less than thirteen clear days nor more than forty-five days prior to May 20, 2021; and

WHEREAS, the Authority has caused to be prepared plans, specifications and form of contract, together with estimate of cost, which are now on file in the office of the Woodbury County Auditor for public inspection, for the construction of the public improvements; and

WHEREAS, on April 20, 2021, the Authority fixed a date for receiving bids for the Detention Equipment Contractor and Security Electronics Contractor and their respective scopes of work as outlined in Division 11 and Division 28 of the proposed specifications on file, said date to be May 13, 2021 at 2:30 P.M., for purposes of including the lowest bid as an addendum to the plans and specifications on file for the construction of the public improvements; and

WHEREAS, the plans, specifications and form of contract are deemed suitable for the making of the public improvements; and

WHEREAS, before the plans, specifications, form of contract and estimate of cost, including addenda thereto, may be adopted, and before a contract for the construction of the public

improvements is entered into, it is necessary, pursuant to Chapter 26, Code of Iowa, to hold a public hearing and to advertise for bids:

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE WOODBURY COUNTY LAW ENFORCEMENT CENTER AUTHORITY:

Section 1. That it is hereby determined that it is necessary and advisable to construct certain public improvements described in general as the Woodbury County Law Enforcement Center, in the manner set forth in the plans and specifications and form of contract, above referred to, the cost thereof to be paid in accordance with the provisions as set out in the posted Notice to Bidders and published Notice of Public Hearing; the public improvements being more generally described as follows:

The scope of work for the above referenced project shall consist of the construction of a new 122,000 square foot Law Enforcement Center Facility which shall include the Sheriff's Office, County Jail, Courts and supporting spaces.

Section 2. That the Board of Commissioners hereby delegates to the Secretary of the Board of Commissioners the duty of receiving, opening and tabulating bids for construction of the Project. Bids shall be received and opened as provided in the public notice and the results of the bids shall be considered at the meeting of this Board on May 27, 2021, at 2:30 P.M.

Section 3. That the Secretary of the Board of Commissioners be and is hereby directed to publish notice of hearing once in a legal newspaper, printed wholly in the English language, published at least once weekly and having general circulation in this County. Publication shall be not less than four clear days nor more than twenty days prior to the date hereinafter fixed as the date for a public hearing on the plans, specifications, form of contract and estimate of costs for the project, the hearing to be at 3:10 P.M. on May 11, 2021.
