RESOLUTION ORDERING CONSTRUCTION AND FIXING A DATE FOR A PUBLIC HEARING ON THE PLANS, SPECIFICATIONS, FORM OF CONTRACT AND ESTIMATE OF COSTS FOR THE WOODBURY COUNTY LAW ENFORCEMENT CENTER SITE DEVELOPMENT PACKAGE

WHEREAS, it is deemed advisable and necessary to construct certain public improvements described in general as the Woodbury County Law Enforcement Center Site Development Package; and

WHEREAS, the Authority has caused to be prepared plans, specifications and form of contract, together with estimate of cost, which are now on file in the office of the Woodbury County Auditor for public inspection, for the construction of said public improvements; and

WHEREAS, the plans, specifications and form of contract are deemed suitable for the making of the public improvements; and

WHEREAS, before the plans, specifications, form of contract and estimate of cost may be adopted, and a contract for the construction of the public improvements is entered into, it is necessary, pursuant to Chapter 26, Code of Iowa, to hold a public hearing.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE WOODBURY COUNTY LAW ENFORCEMENT CENTER AUTHORITY:

Section 1. That it is hereby determined that it is necessary and advisable to construct certain public improvements described in general as the Woodbury County Law Enforcement Center Site Development Package, in the manner set forth in the plans and specifications and form of contract, above referred to, the cost thereof to be paid in accordance with the provisions as set out in the

published Notice of Public Hearing; the public improvements being more generally described as follows:

The scope of work for the above referenced project shall consist of rough grading and limited underground utility installation on the site in preparation for the new Woodbury County Law Enforcement Center Facility. The project is located at 3701 28th Street, Sioux City, Iowa 51101.

BE IT FURTHER RESOLVED, that the Secretary of the Board of Commissioners be and is hereby directed to publish notice of hearing once in a legal newspaper, printed wholly in the English language, published at least once weekly and having general circulation in this County. Publication shall be not less than four clear days nor more than twenty days prior to the date hereinafter fixed as the date for a public hearing on the plans, specifications, form of contract and estimate of costs for the project, the hearing to be at 10:00 A.M. on April 28, 2021.
