Tito Parker, Board Chair, called the meeting to order at 4:35 p.m. Roll call was taken with twelve members being present.

Shelly Sorensen moved and Tina Young seconded to approve the Personnel & Finance Committee minutes and the Board meeting minutes of January 16, 2020. Motion carried.

Jean mentioned that she's been doing media coverage about the LIHEAP program which ends April 30th. The average assistance this year is \$425.00. She was contacted by Senior Service America (SSA), who contracts with the Dept. of Labor to administer the Senior Community Service Employment Program (SCSEP). West Central in lowa will be giving up their slots so SSA may not apply for any slots in lowa for the next program year. There was discussion; Jean will keep board members informed as details are worked out.

David Dawson made a motion and Ruth Ann Uhl seconded to approve the Board Treasurer's Report of January, 2020. Motion carried.

Rachael Ostermyer reported that the Policy Council reviewed and approved the EHS and HST job descriptions. Andy presented the audit. Beth Cox from Regional will be here in March for our site review and will attend the Policy Council meeting. February 29th is the program year end for HST, EHS and our new EHS expansion.

New Business:

Form 990:

The Form 990 was emailed to Board members for their review. Norma DeLaO moved and Erica Brown seconded to approve the Form 990. Motion carried.

Head Start Eligibility Training:

Michelle Eyer had a hand-out about Rules and Guidelines for Eligibility Training. She reviewed the general provisions, definitions of homeless families and families, income and age requirements, eligibility, ethics, confidentiality, program responsibilities and policies.

DQ Smiles and Stories:

David Dawson moved and Tina Young seconded to retroactively approve submission of a DQ Smiles and Stories grant in the amount of \$2,926 for Second Step Child Protection Units for Head Start. Motion carried. Jean mentioned we received notification that we were not granted these funds.

CSBG-19-18:

A motion was made by Norma DeLaO and seconded by Shelly Sorensen to approve a request for a 3-month extension through June 30, 2020 of CSBG-19-18. Amount to be carried over is approximately \$151,000. Motion carried.

Job Descriptions:

When we first applied for Early Head Start expansion we combined the job description for Head Start and Early Head Start teachers. The Educational requirements differ so we have created separate job descriptions for Head Start Teacher and Early Head Start Teacher, so moved to approve by Norma DeLaO, seconded by David Dawson. Motion carried.

Board Term Expirations:

Terms expiring in March are Pastor Catie Newman and Char Hesse, elected representatives from Districts 3 & 4; Sally Harley and Heidi Nelson, public official representatives appointed by the Board of Supervisors; Harlan Salvatori, Pastor Sheryl Ashley and David Dawson, private interest representatives appointed by our Board of Directors. Harlan and David both volunteered to serve another term.

Volunteer Committee:

Tito Parker, Rocky De Witt and Ruth Ann Uhl will serve on the committee to oversee the board officer election in March and the election for Districts 3 & 4.

Executive Director Evaluation:

Norma DeLaO moved and Tina Young seconded to go into Executive Session for discussion of the Executive Director's evaluation performed by the Executive Committee.
