Current Critical Path: Currently, the critical path is being driven by the structural foundations, in a sequence from Lower C to Upper A to C. Heartland Concrete in working on foundations in lower A and C. MEP activities are also moving through the site installing sleeves in the foundation walls. The foundations are then driving the precast and steel erection a lower A to C then to Upper A to B. The precast and steel erection is then driving the interior buildout of the entire structure, in a sequence of lower A, to lower C, to upper A, to area B, and finishing in upper C. Then framing and overhead MEP activities in lower C will begin and inwall activities will shortly follow behind the framing.
