Woodbury County issued a request for proposal for voting equipment. These RFPs will be opened at the Board meeting following a public hearing.

BACKGROUND:

The County is moving forward to purchase voting equipment. The Code of Iowa requires a competitive bid process. A request for proposal has been issued with the RFPs due by 4:30 PM on July 17th.

FINANCIAL IMPACT:

\$500,000 has been authorized for the purchase of voting equipment.

Here is the information on the 2 companies that turned in bids for the election equipment.

Henry M Adkins & Son, INC

Hardware cost of \$483,580.00 plus Software cost of \$17,738.00 less Iowa discount & trade of (\$72,537.00) for a total Hardware and Software cost of \$428,781.00.

Then the Annual License Fees of \$27,918.00 and Annual Maintenance Fees of \$23,785.00 for total Annual Fees of \$51,703.00.

Elections Systems & Software, LLC (ES&S)

Hardware cost of \$473,456.00 plus Software cost of \$21,365.00 plus performance bond of \$6,219.61 less discount & trade allowance of (\$86,400.00) for a total Hardware and Software cost of \$414,640.61.

Then the Annual Fees of either Silver coverage at \$39,305.00 OR Gold coverage of \$42,065.00. (These numbers include both License and Maintenance Fees.)
