## Information for the public interested in scheduling a civil ceremony

To schedule a civil ceremony with a judge at a courthouse call: 712-279-6031

Civil ceremonies held during the work day at a court facility with a judicial officer are free to the public. Civil ceremonies scheduled with other officiants or scheduled for other times/locations may be charged up to \$200.00 – it is up to the parties to negotiate the fee with the officiant.

The Code of Iowa, Section 595.10, provides that, in addition to judges, the following individuals may solemnize a marriage: “A person ordained or designated as a leader of the person’s religious faith.”
