## **Sioux City Board of Review Vacancy**

Application Deadline: January 1, 2026

The Sioux City Conference Board is seeking a person to fill the position as a member of the Sioux City Board of Review. The Board is comprised of three members whom reside within the city limits of Sioux City. The board members are appointed by the Sioux City Conference Board to review assessments made by the Sioux City Assessor.

#### Members are responsible for the following duties:

- This board hears appeals of any Property Owner/Taxpayer who feels their assessed value, property classification or related property exemptions are not correctly assessed or implemented as required by Iowa law.
- This board consists of three members. As nearly as possible this board shall include one licensed
  real estate broker and one licensed architect or person experienced in the building and
  construction field. Not more than two members of the board of review shall be of the same
  profession or occupation and members of the board of review shall be residents of the assessor
  jurisdiction.
- Each member must have knowledge of property values in the city by reason of their occupation.
- The current vacancy needs to be filled by an individual who is either a licensed real estate broker or one licensed architect or person experienced in the building and construction field.
- Iowa Code (69.16A) requires gender balance on all boards.

### Meeting schedule & time commitment

Members meet in the month of May every year and possibly in November of odd numbered years. This board usually meets from 9:00 AM until 4:00 PM on days of hearings at the Woodbury County Courthouse.
