Minimum due at hook-up: \$200.00* subject to change \$175.00 every 7 days.

Minimum due at hook-up with S.T.: \$250.00* subject to change \$175.00 every 7 days.

Out of County Orders: \$35 per day Fees must be paid in full the day of hook up.

* Payment must be made each week.

*Payments are made either in E.M. Office between the hours of 7am to 3:30 pm, or by phone.

*CASH Payments must be **EXACT.**

*Debit/Credit transactions may have additional fees.

Be prepared for a Drug Test (Mandatory, done in EM office, day of hook up)

Ride to and from our office if you do not have valid drivers license.

If you do not have a valid license and are observed driving, you will do your time in jail.

If you have a valid license, you will need to provide the following:
-valid D.L.
-proof of insurance
-proof of registration

If you are **self employed**, you will need to bring some kind of proof of employment, LLC paperwork, a tax document, professional license, or insurance paperwork.

ELECTRONIC MONITORING RULES AND REGULATIONS



The Woodbury County Sheriff's Office offers an in-house detention program using a GPS electronic monitoring system.

The program provides an alternative to incarceration for certain approved non-violent offenders who may require less than institutional custody.

This program allows and encourages you to work during your sentence.

HOW TO APPLY:

You and your Attorney must complete an application form and submit it to the EM Office for review.

Arrangements to serve time on Electronic Monitoring must be made

WITHIN 20 days of your sentence date. DO NOT call or show up on the scheduled date of turn in expecting to be allowed into the program.

After the application has been given to the EM Office, **YOU** must contact the EM Office at (712-279-6594) for an Interview.

During the interview: rules, cost, and regulations will be discussed with you, and an electronic monitoring date is set.

After the interview, the application will either be approved or denied. Any additional information will be sent to your attorney.



Approval by both Judge and EM Staff is required.

No escape convictions

Must agree to random alcohol/drug screening

Must agree to random home visits

No conviction for forcible felony or crimes involving serious injury

Approval is on a case by case basis

Must not have any active warrants from any other jurisdiction

If required, must agree to alcohol testing equipment

No applicants will be accepted for a period less than seven (7) days
