## Bogenrief Studios – Stained Glass Windows & Light Globe Update

Kenny and Shane went to the Bogenrief Studios to check on some concerns on the timeline for the light globes and the windows. To make the globes is a very difficult process. Bogenrief purchased additional kilns to help with the process of making the globes. The globe mold had to be made and that is part of the concern of the timeline. When Bogenrief is finished with getting the formula right, he will give the mold with the paper work to the County for future record. This will not be at a cost to the County. Bogenrief still plans on getting everything done on time. There are five large useable globes in the courthouse basement that are available.

It is a two week time frame from when they put the windows together to when they are actually done.

Courtroom #207 should be done by May 25<sup>th</sup>.

Kenny found the 1991 preservation study for the courthouse from Wetherell Ericsson Architecture.

## **Responses from Dignitaries & V.I.P's**

Jeremy suggested that the committee set a date with a week long of events for the ceremony and in January 2018 contact Governor's office to see which day would work for them.

Jim suggested that March would be a bad time to have the ceremony because of weather.

  - Guy Wilson is a professor from University of Virginia. He has information on William Steele. (County would pay for transportation and potentially an honorarium)

  - Palmer Candy Maybe they could do something for example a chocolate courthouse
  - Christmas ornaments
  - Building replicas of the building in wood
