Reviewed upcoming meetings.

Commissioners stated that Hoelker should try to attend some of the Hungry Canyons Alliance meetings, but that he should check with the County Engineers to see if any of them will be attending as they may be able to carpool.

At this time, it doesn't appear that any of the commissioners will be able to attend the Partnership Day in Des Moines.

Tabke may attend the ISU Fall Grazing Tour at the Castana Research Center.

(18-169) Motion by Bromander, second by Walters to approve the 18 conservation plan revisions. Carried unanimously.

NRCS Report

Evans presented her NRCS report. Evans has been working in both Monona and Woodbury counties as she has been training the soil con in Onawa. Noted that Jayme Uhl has been hired as the new Conservation Assistant and that she will start December 10th.

Watershed Report

Hoelker provided the commissioners with a spreadsheet showing site inspections for the past month and gave an update of his findings. We have Mark Petit hired to do brush removal on 3 sites and Hoelker will bring pictures to the next meeting.

We have a potential maintenance project on Neustrom M-4. There is shoreline erosion. Met with Gary Bruce (contractor) and he estimated that it would cost \$2,500 just for dirt work. Hoelker thought that we should add some riprap if we could find some broken concrete as it would be cheaper than getting rock. Commissioners suggested talking with Brian Meyers, NRCS Engineer, to get a good idea/estimate for fixing the structure and then talking to Mark Nahra, County Engineer, to see if we would be able to get some broken up concrete from them and if they would haul it to the site. Then once we have a good estimate, talk to the landowner to see if he would be willing to pay ½ of the repair cost.

Hoelker gave commissioners a copy of the Summary of Current Policy for Little Sioux Structure Repair and suggested that commissioners review this and then maybe each meeting we could start to update it.

(18-170) After some discussion, Bromander moved that we pay \$30/tail verified for trapping beaver whether in season or out of season. Seconded by Tabke. Carried unanimously.

(18-171) After some discussion, Bromander moved that we only pay landowners for maintenance on their own structures on a case by case basis after being approved by the board. Seconded by Walters. Carried unanimously.

Discussed repairing structures that have issues because of livestock overgrazing and cattle trails. Decided that our first course of action will be to notify the landowner that they need to remove the cattle from the structure and fence off the watershed structure and to note that the landowner is responsible for maintenance issues caused by the cattle being on the watershed structure – meaning that either the landowner will repair the issues himself or the District will repair it and then bill the landowner.

The next commissioner meeting will be at 8:30 AM, Tuesday, December 18, 2018 at the office in Sergeant Bluff.

(18-172) Motion by Walters, second by Bromander not to pay Heiserote for completing brush/tree removal on his watershed structure as it was not approved by the commissioners prior to doing the work. Carried unanimously.
