Resolution Fixing Date of Hearing on Lease

Dear Michael:

We have now prepared and are enclosing suggested proceedings to be acted upon by the Board of Commissioners in fixing the date of a meeting on the proposition to enter into a Lease Agreement with Woodbury County, Iowa and ordering publication of a notice of hearing.

Publication Requirement - Notice of Hearing.

Notice of this meeting must be published at least once in a legal newspaper, printed wholly in the English language, published at least once weekly, and having general circulation in the County. The <u>date of publication</u> is to be <u>not less than four clear days nor more than twenty days</u> before the date of the public meeting on the proposition to enter into the Lease Agreement. In computing time, the date of publication should be excluded. If the last day falls on Sunday, the whole of the following Monday should be excluded. [See Section ICS 4.1(34).]

At the time of hearing the Board of Commissioners shall receive oral or written objections from any resident or property owner to the proposed action to enter into a Lease Agreement with Woodbury County, Iowa. After all objections have been received and considered, the Board of Commissioners is required, at that meeting or at any adjournment thereof, to take additional action for the authorization of the Lease Agreement or to abandon the proposal.

Please return a completed copy of the proceeding, via email followed up by a hard copy, filled in as the original and certified back to us. We are also enclosing an extra copy of the notice of hearing to be delivered to the newspaper for publication purposes. A certificate to attest the proceeding is attached as well.

RESOLUTION FIXING DATE FOR A PUBLIC HEARING ON THE PROPOSAL TO ENTER INTO A LEASE AGREEMENT WITH WOODBURY COUNTY, IOWA

WHEREAS, the Woodbury County Law Enforcement Center Authority (the "Authority"), is a body corporate, organized and existing under and by virtue of Iowa Code Section 346.27, and any successor legal authority thereto; and

WHEREAS, Iowa Code Section 346.27 provides that the Authority shall have and exercise certain public and essential governmental powers and functions including the right to lease all or any part of a building to an incorporating unit upon rental terms agreed upon between the Authority and the incorporating unit;

WHEREAS, the Authority and Woodbury County, Iowa (the "County") have negotiated the form of a proposed Lease Agreement (the "Lease") by and between the Authority and the County, which would obligate the Authority to construct certain improvements to be operated by the County as a law enforcement center facility (more particularly described in the Lease) on certain real property located within Sioux City, Iowa as defined and legally described in the Lease, consisting of the construction of an approximately 213,000 square foot building, together with all related site improvements, under the terms and following satisfaction of the conditions set forth in the Lease and would obligate the County to make certain payments to the Authority as outlined in the proposed Lease, under the terms and following satisfaction of the conditions set forth in the Lease; and

WHEREAS, neither Section 346.27 nor any other Code provision sets forth any procedural action required to be taken before said Lease can be approved, and the Authority hereby deems it sufficient if the action hereinafter described be taken and the Secretary of the

Board of Commissioners cause to be published notice of the proposal and of the time and place of the meeting at which the Board of Commissioners proposes to take action thereon and to receive oral and/or written objections to such action.

WHEREAS, the following action is now considered to be in the best interests of the Authority.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF WOODBURY COUNTY LAW ENFORCEMENT CENTER AUTHORITY:

Section 1. That this Board of Commissioners meet in the First Floor Supervisors' Board Room, Woodbury County Courthouse, 620 Douglas St., Room 105, Sioux City, IA, at 11:00 A.M. on July 21, 2020, for the purpose of taking action on the matter of the proposal to enter into the Lease with Woodbury County, Iowa.

Section 2. That the Secretary of the Board of Commissioners is hereby directed to cause at least one publication to be made of a notice of said meeting, in a legal newspaper, printed wholly in the English language, published at least once weekly, and having general circulation in Woodbury County, said publication to be not less than four (4) clear days nor more than twenty (20) days before the date of said public meeting.

Section 3. The notice of the proposed action shall be in substantially the following form:

CONSENT FOR USE

B.I.L. Corp., Inc., an Iowa corporation conveyed to the City of Sioux City, a Municipal Corporation by Warranty Deed dated October 29, 2010 and filed for record January 14, 2011 on Roll 714, Images 5447-5448 in the Woodbury County, Iowa Auditor and Recorder's Office, land described as follows:

The South One-half (S½) of the Southeast Quarter (SE¼) in Section Fourteen (14), Township Eighty-nine (89) North, Range Forty-seven (47) West of the Fifth Principal Meridian, Woodbury County, Iowa, consisting of 77.51 acres, more or less.

Subject to and together with covenants, conditions, restrictions and easements of record, if any.

The said Warranty Deed also recited, in part, as follows: This deed represents a gift to the City of Sioux City, Iowa for the creation of a new public park which shall be known as "LIBERTY PARK", and such other municipal uses as the Grantor may approve while retaining the "LIBERTY PARK" name to such other municipal uses.

The Woodbury County Law Enforcement Center Authority, a body corporate, organized and existing under and by virtue of Iowa Code Section 346.27, and any successor legal authority thereto, now desires to purchase the following described tract of land from the City of Sioux City, a Municipal Corporation for the construction of a new law enforcement center facility:

The Southeast Quarter (SE½) of the Southeast Quarter (SE½) in Section Fourteen (14), Township Eighty-nine (89) North, Range Forty-seven (47) West of the Fifth Principal Meridian, Woodbury County, Iowa,

consisting of 38.27 acres, more or less, except road right-of-way (Parcel No. 894714400008) described as follows:

A new right-of-way dedication to that part of 28th Street lying in part of the Southeast Quarter of Section 14, Township 89 North, Range 47 West of the Fifth Principal Meridian, Woodbury County, Iowa, more particularly described as follows:

Commencing at the Southeast corner of said Section 14; thence N 02°27'17" E along the East line of said Section 14 for 46.97 feet measured (47.00 feet recorded) to the North line of existing 28th Street being the point of beginning; thence continuing N 02°27'17" E along said East line of Section 14 for 20.00 feet; thence N 87°19'47" W for 913.64 feet; thence S 02°40'09" W for 20.00 feet to the North line of said existing 28th Street; thence S 87°19'47" E along the said North line of existing 28th Street for 913.72 feet measured (913.74 feet recorded) to the point of beginning. Containing a total area of 18273.57 square feet or 0.42 acres.

Based upon discussions between B.I.L. Corp., Inc., various officials for Woodbury County, Iowa and various representatives of the Woodbury County Law Enforcement Center Authority and in keeping with the site plan, attached hereto, B.I.L. Corp., Inc. does hereby consent to the use of the 38.27 acres, more or less, tract of land for the following purposes:

Construction and operation of a new law enforcement center facility, which is not required to use the name "LIBERTY PARK".

The deed restriction regarding the creation of a new public park which shall be known as "LIBERTY PARK", and such other municipal uses as B.I.L. Corp., Inc. may approve while retaining the "LIBERTY PARK" name to such other municipal uses, is retained as to the balance of the real estate described above and not conveyed to the Woodbury County Law Enforcement Center Authority.
