Approval of Minutes

Variance Setback Reduction Request (Kathleen Sonksen)

Priestley presented the staff report for Kathleen Sonksen's variance application for a 20 ft front yard setback reduction from 100 ft to 80 ft to facilitate the construction of a new single-family dwelling for Wesley and Melanie Pierce. The hardship is a result of significant changes in elevation as well as an unusual right-of-way location. The property is identified as Parcel 86430330000; Township: T86N R43W (Oto); Section: 4; Quarter: SE ¼ SW ¼; Zoning District Agricultural Preservation (AP); Floodplain District: Zone X (Not in Floodplain); Address: 3885 290th Street, Oto, IA 51044. It is the recommendation of staff to approve the variance. Brouillette asked about land owner relationship to the Pierce's, Wesley Pierce stated Kathleen Sonksen is his mother-in-law. New home would be located on a flat area slightly back from the original homes' location. Woodbury County Engineer's Office has no objection to the setback variance. Brouillette stated this request is a good example the intended use of a variance. A motion was made by Brouillette to close the public hearing; second by Christensen. Motion passed 3-0. A motion was made by Brouillette to recommend approval the variance request for reduction of front yard setback from 100 ft to 80 ft; Second by Christensen; Motion passed 3-0.
