A total of 6 RFP Grant Applications for Stewardship Committee were received and approved. The Loess Hills Alliance thanks Lance Brisbois for the work that he did on the Stewardship Committee RFP Grant process.

**Protection Committee** – No report from Chairman, Graham McGaffin.

**Stewardship Committee** – Lance Brisbois reported that the Stewardship Committee did not meet this morning. A total of 6 RFP Grant applications for Stewardship Committee were received. The Stewardship Committee approved 4 RFP Grant applications at the last Stewardship Committee meeting on February 2<sup>nd</sup>. The Stewardship Committee thanks the Executive Committee for the \$4,220.00 funding received to help fund the remaining two RFP Grant applications. Agreements are in the process of being signed.

**Economic Development Committee** – Renea Anderson reported that the committee met on Monday, February 28<sup>th</sup> at 10:00 AM, Harrison County Welcome Center, Missouri Valley. Edits for the Loess Hills Birding, RVing, and Motorcycling Brochures are being turned in to the Economic Development Committee. Final edits are due on March 7, 2022. Printing will be done in April, before spring season starts.
