- Grille and ductwork Leave both in place.
- Balancing damper Close it.
- Fire damper Close it and leave in place.
- Labeling Label the duct and grille as "abandoned in place."

Room 0030

- Grille and ductwork Leave both in place.
- Balancing damper No action required.
- Fire damper Leave in place.
- Exhaust fan (EF-5) Turn off.

Room 0031

- Grille and ductwork Cut duct at wall, seal remaining duct connected to EF-1 (Patching Wall by others / not included; verify requirements with GGA).
- Balancing damper Close it.
- Fire damper Not present.

As the owner has elected not to proceed with rebalancing EF-1, any resulting discrepancies in system performance or airflows will not be the responsibility of C.W. Suter. We recommend that EF-1 be rebalanced post-modification to ensure optimal system performance and to avoid potential operational issues throughout the building.
