MINUTES OF THE THURSDAY, SEPTEMBER 11, 2025, BOARD MEETING**

The following is a true copy of the minutes of the meeting of the Woodbury County, Iowa, Conservation Board held on Thursday, September 11, 2025, at the Dorothy Pecaut Nature Center beginning at 4:00 p.m.

Chairperson Tom Limoges called the meeting to order at 4:03 p.m.

ITEM R1. Approve Consent Agenda

ITEM R2. Riverside Land Request

Tom shared a request from an interested party to purchase conservation land in Riverside Hills for residential development. Dan explained that the land was acquired with REAP grants to prevent development, and selling would require repayment at current value. He recommended that the board does not sell it, even though it has been a difficult area to manage.

(Chris arrived at 4:06 p.m.)

Staff and board members expressed concerns about selling conservation land, despite it being within city limits, because it is part of the Loess Hills and scenic byway and there are cultural resources on the property.

ITEM R6. Board Member/Staff Reports

1. Administrative Items

f. Endowment Update

Discussion was held on the proposed Nature Center addition. Dan, Brian and Theresa recently met with the CMBA architects to determine the best location option for the addition. Terry Glade suggested doing two levels instead of three because of the elevator. They would create a rendition drawing and 3D model of the nature center with the new addition. Any construction would have to wait a year until the building's foundation situation is figured out. Dan reported that nature center staff have raised concerns about the animal displays and how they were obtained, the aesthetics of the

addition, and the overall alignment with the nature center's mission. It was also noted that the project needs to be discussed with the Pecaut family and the Foundation before moving forward.

The board agreed by consensus to table action on the CMBA agreement until next month and asked for staff to make contacts with the Pecaut family and Foundation before next month's meeting.

g. Needs Assessment Survey Questions Review

Dan presented the survey questions proposed by SIMPCO and stated that they would like to limit the survey to 15-20 questions. The board reviewed and updated the list of questions, and Dan will send them to SIMPCO.

2. Little Sioux Park Internet

Brian presented a quote from the contractor who ran fiber to the concession stand last year for expanding the Wi-Fi to cover the campgrounds. He explained that cell phone service isn't very strong, and Wi-Fi will be needed to introduce acceptance of online payments using QR codes at the campsites. The quote includes coverage for Bellamy and Riverside campgrounds, as well as Heritage Shelter. Some of the backbone equipment that will be needed to cover Riverside campground has already been installed. There would be an option to make one channel free and offer faster speed channels for a fee to campers. It was noted that it would be a good safety feature for receiving severe weather warnings, in addition to being used for entertainment.

ITEM R3. Google Great Outdoor Foundation Opportunities

Dan reviewed his previous discussions with Bolton & Menke a couple years ago when they were looking for projects that might qualify for the Great Outdoor Foundation and its priorities. They had sent an email to all counties in northwest Iowa, but only Woodbury and Plymouth responded. Dan had suggested Owego and Oak Ridge as possible projects at that time, but nothing came of it. He reported that recently Google and the Great Outdoor Foundation have

changed their deliverables and expressed renewed interest in the Owego and Oak Ridge dam projects.

At Owego, they would look at expanding some of the basins that are narrow and silted in and possibly pumping water from the ditches using solar power to filter it through the cells. A new high-risk dam could be built at Oak Ridge creating another pond. They could also possibly raise the level in the existing dam at Fowler Forest.

ITEM R4. Department Reports

1. Nature Center Activities

Theresa reported on the following Nature Center activities:

- The program and visitor reports for July and August were presented.
- Summer camps and events were successful, including the Meet the Animals event with the SDSU ice cream truck and the Summer Send-Off event with root beer floats and nature play activities for families.
- Field trips and classroom programs are being scheduled.
- School of the Wild is scheduled with Woodbury Central fifth graders at Southwood Conservation Area on September 29-October 2.
- Nature Calls:
 - Sponsorships are up to \$25,400 in hand with an additional \$4,125 pledged. A few sponsors have not returned this year for a variety of reasons.
 - More volunteers were needed due to needing to pour beer for 11 of the 16 tables. The Glazers sales team won a trip and ballgame tickets for the same weekend. Suppliers have stated that it is harder to get their staff to volunteer for these types of events.
 - Ticket sales are down quite a bit. Last year a total of 165 tickets were sold, which was low in comparison to previous years at over 250. There are a lot of other events going on for other nonprofit organizations the same weekend.
- The pollinator mural installation did not go well but is being resolved and should be finished this weekend.
- Two large events are planned for the nature center's 30th anniversary in October.
 - A Hike-a-thon will be going on all month. Scheels is providing prizes, and Absolute Screen Art is printing bandanas.
 - A family-friendly celebration event will be held on October 18th with various family activities and a live eagle presentation.

2. Park Activities

Brian reported on the following park activities:

- Labor Day weekend went smoothly with no major incidents. Attendance was mixed with a couple of campgrounds being full and others 50-75% full.
- Snyder Bend staff has been working on pumping at Owego.
- The drag line has finally been removed from Owego.
- Southwood staff have been working on habitat improvement projects, mowing, and prairie restorations. They also helped the LEC by mowing around the jail building.
- Little Sioux staff has been keeping up on maintenance since losing all but one of their seasonal employees. They also completed shouldering work on the new park road section and have been hauling asphalt grindings and spreading them where needed.
- A quote was received from Sir Lines-A-Lot to paint stripes on the Little Sioux roads for \$1800 and the nature center parking lot for \$1600.
- Upcoming trainings include pesticide, emergency vehicle operation course (a new requirement), and CCPOA pistol qualification & other CEUs.

3. Little Sioux Outlet Cleanout

Dan reported that the quote for the Little Sioux outlet cleanout came in at about \$5,000. It will be cleaned out with a long reach excavator, piled on the south bank until dry, and then hauled to the west side of the road. Brian stated that it won't all be assessable with the long reach, so they will have to make a bench.

ITEM R6. Board Member/Staff Reports

1. Administrative Items

Dan reported on the following items:

a. Set Next Meeting Date and Location

The next meeting will be held at 4:00 p.m. on October 9, 2025, at Brown's Lake Bigelow Park.

b. Concession Stand Financials

Dan reported on the concession stand sales for the summer. Brown's Lake concession was open May 24th through August 31st and had total gross sales of \$12,589, including 679 rentals accounting for \$6,420. Little Sioux concession was open July 19th through September 1st and had total gross sales of \$5,323 including 299 rentals accounting for \$2,796. Dan stated that, after discussions with staff, he has decided to purchase an additional pedal boat for Little Sioux Park next spring.

c. Budget FY 26/27

Dan presented an initial draft of the FY27 budget, which is essentially the same as last year, with the addition of the motor vehicle line again. He is also going to request bringing the rest of the seasonal staff back, other than the security guards. He noted that there might be a few other tweaks within the budget, and he will have it ready for approval next month.

d. CF Industries Agreement

Dan stated that he hopes to receive a call from the county attorney tomorrow to address the CF Industries agreement. The attorney is concerned about wording that allows people other than CF Industries to access the property. Dan doesn't believe it would create a county liability though, since it is simply a management agreement and will still be owned by CF Industries.

e. Nature Center Cleaning Contract

Dan informed the board that the nature center cleaning service had given notice and quit effective July 1st. He decided to try having nature center staff clean the center to save county money, but after a month and a half, he realized it was a mistake. It took many more staff hours than he expected, although he noted that it was the cleanest the center has been in years. He obtained bids and has contracted with Bright and Shine Cleaning Service at an annual cost of \$15,168, which is a cost savings of \$1,300 compared to the previous service. They will clean twice a week on Mondays and Fridays.

Brian and Dan have been talking with the DOT on a possible collaboration with the DOT, Iowa State Extension, UNI, and the conservation department for a roadside prairie project at their building on Highway 20.
