**EXECUTIVE SUMMARY:**

The county received bids for the above captioned bridge project through the Iowa DOT bid process. The bids have been reviewed and an award is recommended.

**BACKGROUND:**

The county engineer completed plans for the replacement of a bridge on Old Highway 141 southeast of Sioux City, bridge number G-178. The bridge is load restricted due to deterioration of the deck and superstructure. The new bridge is an 90' x 30' three span continuous concrete slab bridge. The project includes new bridge approach sections and some new PCC paving.

**FINANCIAL IMPACT:**

The project is paid for with 80% federal aid/20% Woodbury County farm to market fund money.
