ITEM ONE (1)

Petitioner Jerald R. Day and Karen H. Day

Pursuant to Section 335 of the Code of Iowa, 2007, the Woodbury Count Board of Supervisors held a public hearing on April 14, 2009 to amend the Woodbury County Zoning and Subdivision Ordinance and/or Map for the unincorporated area of Woodbury County, Iowa, as follows:

Amendment to rezone from (AP) Agricultural Preservation to AE (Agricultural Estates) for a parcel located in Section 17, T89N, R46W of the 5th P.M. in Woodbury County, Iowa described as follows:

The N $\frac{1}{2}$ of the SW $\frac{1}{4}$ of Section 17, Township 89 North, Range 46, West of the 5th P.M., except that part of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ lying North and East of the road, in the County of Woodbury and State of Iowa; and EXCEPTING therefrom the following described parcels:

PARCEL A:

Beginning at the SE corner of said N $\frac{1}{2}$ of the SW $\frac{1}{4}$; thence S 89°47'00" W along the southline of said N $\frac{1}{2}$ of the SW $\frac{1}{4}$ for 1244.58 feet; thence N 0°00'00" E for 350.00 feet; thence N 89°47'00" E for 1244.58 feet to the eastline of said N $\frac{1}{2}$ of the SW $\frac{1}{4}$; thence S 0°00'00" W along said eastline for 350.00 feet to the point of beginning. Containing 10.000 acres including County Roadway and 9.735 acres excluding said Roadway.

Note: The east line of said N $\frac{1}{2}$ of the SW $\frac{1}{4}$ is assumed to bear S 0°00'00" W.

PARCEL B:

Commencing at the SE corner of said N $\frac{1}{2}$ of the SW $\frac{1}{4}$; thence S 89°47'00" W along the southline of said N $\frac{1}{2}$ of the SW $\frac{1}{4}$ for 1244.58 feet to the point of beginning; thence continuing S 89°47'00" W along said southline for 1377.94 feet to the SW corner of said N $\frac{1}{2}$ of the SW $\frac{1}{4}$; thence N 0°06'55" W along the westline of said N $\frac{1}{2}$ of the SW $\frac{1}{4}$ for 1311.50 feet to the NW corner of said N $\frac{1}{2}$ of the SW $\frac{1}{4}$; thence N 89°58'42" E along the northline of said N $\frac{1}{2}$ of the SW $\frac{1}{4}$ for 1250.15 feet; thence S 0°00'00" W 957.25 feet; thence N 89°47'00" E for 130.42 feet; thence S 0°00'00" W for 350.00 to the point of beginning. Containing 38.587 acres.

Note: The east line of said N $\frac{1}{2}$ of the SW $\frac{1}{4}$ is assumed to bear S 0°00'00" W.
