

WOODBURY COUNTY, IOWA
ORDINANCE # 30

AN ORDINANCE FIXING THE BOUNDARIES
OF THE WOODBURY COUNTY VOTING PRECINCTS AND THE
SUPERVISOR DISTRICTS IN WOODBURY COUNTY

(This Ordinance Repeals and Replaces Woodbury County Ordinances #12 and #13)

BE IT ENACTED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF
WOODBURY, IOWA:

SECTION 1: THE BOUNDARIES OF THE VOTING PRECINCTS IN WOODBURY
COUNTY, IOWA, EXCLUDING THOSE PRECINCTS INSIDE THE CORPORATE LIMITS
OF SIOUX CITY, IOWA, SHALL BE AS FOLLOWS:

Precinct 15. All of the unincorporated area of Concord Township; and

City of Sioux City, Iowa Precinct 15 as defined by city ordinance.

Precinct 28. All that unincorporated area in Woodbury Township (including that
area known as West Woodbury) described as Census Tract 19, Blocks 1000,
1001, 1002, 1004, 1009, 1025, 1026, and Census Tract 33, Blocks 2010, 2011,
2012, 4001, 5032, 5033, 5034, 5035, 5036, 5065, 5066, 5067, 5068, 5072, 5073
and Census Tract 36, Blocks 5019, 5027, 5028, 5029, 5120, 5121; and

City of Sioux City, Iowa Precinct 28 as defined by city ordinance.

Precinct 29. Woodbury Township, including all that part of the incorporated City of
Sergeant Bluff lying east of the centerline of South Lewis Boulevard and within
Woodbury Township; but except therefrom that part of the incorporated City of
Sioux City, Iowa within Woodbury Township and that part of the incorporated City
of Sergeant Bluff, Iowa lying west of the centerline of South Lewis Boulevard and
within Woodbury Township; and also except that unincorporated area of
Woodbury Township constituting Census Tract 19, Blocks 1000, 1001, 1002,
1004, 1009, 1025, 1026, and Census Tract 33, Blocks 2010, 2011, 2012, 4001,
5032, 5033, 5034, 5035, 5036, 5065, 5066, 5067, 5068, 5072, 5073 and Census
Tract 36, Blocks 5019, 5027, 5028, 5029, 5120, 5121.

Precinct 31. Lakeport Township; and Liberty Township (including that area
known as West Liberty), including the incorporated City of Salix, Iowa within
Liberty Township; but except therefrom that part of the incorporated City of Sioux
City, Iowa within Liberty Township; and except therefrom that part of the
incorporated City of Sergeant Bluff, Iowa within Liberty Township.

Precinct 32. Grange Township and Floyd Township, including the incorporated City of Bronson, Iowa within Floyd Township; but except therefrom that part of the incorporated City of Lawton, Iowa within Floyd Township.

Precinct 33. All of Rutland Township and all of the City of Pierson, Iowa, including that part of the incorporated City of Pierson, Iowa within Rutland Township and that part of the incorporated City of Pierson, Iowa within Union Township.

Precinct 34. Union Township, including that part of the incorporated City of Correctionville, Iowa within Union Township; but except therefrom that part of the incorporated City of Pierson, Iowa within Union Township; and

Kedron Township, including that part of the incorporated City of Correctionville, Iowa within Kedron Township; but except therefrom that part of the incorporated City of Anthon within Kedron Township; and

that part of the incorporated City of Correctionville, Iowa within Rock Township.

Precinct 35. Merville Township and Wolf Creek Township and Arlington Township, including the incorporated City of Merville, Iowa.

Precinct 36. All of Banner Township and all of the City of Lawton, Iowa, including that part of the City of Lawton within Banner Township and that part of the incorporated City of Lawton in Floyd Township.

Precinct 37. West Fork Township and Grant Township.

Precinct 38. Sloan Township, including the incorporated City of Sloan, Iowa.

Precinct 39. Willow Township, including the incorporated City of Hornick, Iowa.

Precinct 40. All of Miller Township and all of the City of Anthon, Iowa, including that part of the incorporated City of Anthon, Iowa within Miller Township; and that part of the incorporated City of Anthon, Iowa within Kedron Township.

Precinct 41. Morgan Township and Liston Township, including the incorporated City of Danbury.

Precinct 42. Little Sioux Township, including the incorporated City of Smithland, Iowa.

Precinct 43. Oto Township, including the incorporated City of Oto, Iowa.

Precinct 44. Rock Township, including that part of the incorporated City of Cushing, Iowa within Rock Township; but except therefrom that part of the incorporated City of Correctionville, Iowa within Rock Township.

SECTION 2: THE BOUNDARIES OF THE SUPERVISOR DISTRICTS IN WOODBURY COUNTY, IOWA SHALL BE AS FOLLOWS:

District number one. District number one shall consist of the following area:
City of Sioux City precincts one, three, five, seven, ten, eighteen, and nineteen.

District number two. District number two shall consist of the following area:
City of Sioux City precincts two, four, six, eight, twelve, sixteen, and seventeen.

District number three. District number three shall consist of the following area:
City of Sioux City precincts twenty-four, twenty-six; and combined City of Sioux City and County precinct twenty-eight; and combined City of Sergeant Bluff and County precinct twenty-nine; and City of Sergeant Bluff precinct thirty; and County precincts thirty-one, thirty-two, thirty-eight, thirty-nine, forty-one, forty-two, and forty-three.

District number four. District number four shall consist of the following area:
City of Sioux City precincts nine, eleven, thirteen, fourteen, twenty, twenty-three, and twenty-five.

District number five. District number five shall consist of the following area:
combined City of Sioux City and County precinct fifteen; and City of Sioux City precincts twenty-one, twenty-two, twenty-seven; and County precincts thirty-three, thirty-four, thirty-five, thirty-six, thirty-seven, forty, and forty-four.

SECTION 3: Repealer. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.
