BOARD OF SUPERVISORS' DIRECTION

On April 11, 2023, the Woodbury County Board of Supervisors directed the Zoning staff to draft an amendment to *Woodbury County Ordinance #56:*An Ordinance Regulating Commercial Wind Energy Conversion Systems in Unincorporated Woodbury County to increase the Wind Turbines Protect Area Turbine Set Back Requirements from the City Limits and Public Conservation Areas. The Board requests for an increase in the setbacks from city limits to 2-miles and an increase in the setbacks from Public Conservation Areas to 2,640 FT or 4.5x tower height setback (whichever is greater) from Conservation Areas.

BACKGROUND

Woodbury County Ordinance #56: An Ordinance Regulating Commercial Wind Energy Conversion Systems in Unincorporated Woodbury County is a stand-alone ordinance that includes guidelines for the development of large-scale Commercial Wind Energy Conversion Systems (C-WECS) by regulating and requiring a C-WECS Special Use Permit for the siting, design, construction, operation, and decommissioning of these wind energy conversion systems (WECS). This proposal is to amend Ordinance #56 to increase the City Limit Setback to 2-miles and the Public Conservation Area to 2,640 FT or 4.5x tower height setback (whichever is greater) from Conservation Areas.

The incorporated areas within Woodbury County have a compelling interest in the land use activities that occur within 2-miles of their respective jurisdictions. Each community has their own plans for expansion and development as well as their own policies on how they expect their growth to trend. Both lowa Code 354.9 and 414.23 acknowledge the incorporated areas authority for land use in this 2-mile zone. Under the extraterritorial review parameters contained within lowa Code 354.9 and acknowledged in the Woodbury County Subdivision Ordinance, Section 1.03.2, "the county shall acknowledge the concurrent review and approval processes by municipalities of subdivisions located within the extraterritorial review jurisdictions of municipalities. The municipal exterritorial jurisdiction area is either the area within two miles of the corporate boundaries of the nearest city or an area described in a specific agreement pursuant to Chapter 28E of the lowa Code."

In terms of public conservation areas, the Woodbury County Conservation Board "is a regional agency tasked with providing high quality and valuable education, recreation, enhancement and preservation of natural resources through professional and courteous service for the betterment of current and future generations." The Board owns and operates "four large developed parks, over 5,000 acres of undeveloped wildlife areas, several day use areas and river accesses." Hence, the Board also has a compelling interest in protecting and preserving public conservation areas for future generations. At the April 13, 2023 meeting of the board, the members approved a motion by a 5-0 vote "to approve support of the Board of Supervisors ordinance change of setback limits for wind turbines near conservation areas of ½ mile or 4 ½ times the tower height" (Woodbury County Conservation Board Draft Minutes, 4/13/23). Subsequently, the Woodbury County Conservation Board at their May 11, 2023 meeting revised their recommendation for the Turbine Set Back Requirement to be 1 mile from public conservation areas. This proposed setback has been updated in the table below for consideration.

The council would also like to hear from the engineer as to what the City's rates might be to pay for the project with revenue bonds.

PUBLIC HEARING 2023/2024 BUDGET -Motion by Lansink second by Kuhlmann to open the public hearing. All ayes. Motion carried. There were no comments from the guests regarding the agenda. Motion by Kuhlmann second by Kirchgatter to close the public hearing. Motion by Motion by Lansink second by Kirchgatter to approve the Resolution approving the 2023/2024 Budget as presented. All ayes. Motion carried.

<u>ALLYSON DIRKSEN - LEGAL</u> - Ms. Dirksen reported she would check on the status of the Don Jones house with the USDA.

BUILDING CODE – MARK POESE – Mr. Poese talked with the council about installing a fence and the need to be 5' off the lot line. Following discussion it was determined that the Ordinance only requires a 2' set back but he could apply for a variance to be be closer/farther away from the property line.

WATER TOWER INSPECTION – the Council discussed the proposal from Magure Iron to inspect the inside of the tower by drone for \$2000 and a bid from MidCo to send divers into the tower to inspect and clean for \$3786. Motion by Kirchgatter second by Lansink to hire MidCo to inspect and clean the tower at their earliest convenience. All ayes. Motion carried.

WIMECA ANNUAL MEETING – The council will decide who is attending the WIMECA Annual Meeting by Thursday, April 13, 2023.

OPTIONAL INSURANCE DEDUCTIBLES & INSURANCE PREMIUM – Following discussion motion by Kuhlman, second by Lansink, to leave the deductible as is and approve the \$69579 insurance premium for the 2023/2024 years. All ayes. Motion carried.

ANTHON EVENT CENTER – BOARD OF DIRECTORS – it was determined to let the present Event Center Board approve a new Board of Directors. The council felt that the new board could amend and update the by-laws for the event center following the election of officers.

CART FOR CHAIRS AT SHELTER HOUSE – Debbie O'Connell mentioned to the clerk that the chairs are scratching the tables when stacked after an event. The Maintenance Department will look at the chairs and see if there is a solution to prevent the scratching of the tables.

<u>SILVERSMITH - GIS MAPPING - KEVIN CARPENTER</u> - talked with the council about GIS mapping of the city's utility lines and fire hydrants. He told the council they can schedule maintenance tasks as well as line locations. The council asked about pin pointing items closer that three to four feet. Mr. Carpenter will send a new proposal with the more precise marking/locating information.

<u>SUBSURFACE SOLUTIONS - GIS MAPPING</u> - the council looked over the brochure and encouraged Maintenance Supervisor Collins to try the 30-day free trial as he can use his phone for this system.

COUNCIL & STAFF COMMENTS – Council member Benson asked about two nuisance properties.

- Benson also told the council that Brad Welte is interested in selling a portion of ground to the city. It
 was determined he should name a price before the City decides to purchase as there are still lots
 available in Westgate Division.
- Mayor Petersen told the council the regulations have changed for meter sockets and she has ordered some to have on hand for new meter installations
- Ms. Petersen also reported the Woodbury County Supervisors are asking for the City's support in restricting windmills to a two mile set back from City limits.
- Council member Lansink reported he has asked I & S Group for a quote to renovate the lift station.
- Maintenance Supervisor Jeff Collins talked with the council about bids he received from Knife River and Frank's Asphalt to do street work this summer. He is waiting on BlackTop Service for another bid before determining how much street work will be done in 2023
- Mr. Collins also reported on the floats at the wastewater treatment plant need re-wiring so they work properly.
- City Clerk Anita Brandt reported she will be at IMFOA Conference next week April 19 thru 21, 2023

There being no further business the council adjourned upon motion by Lansink second by Kuhlmann. All ayes. Motion carried.

My comments, pursuant to the attached request:

- 1. I believe that the current setbacks of 600 feet from City Limits and 600 feet from Public Conservation Areas are too low.
- I agree with the proposed ordinance setback of 2,640 feet or 4.5X tower height (whichever is greater) from Public Conservation Areas.
- 3. I believe that the proposed ordinance setback of 2 miles from City Limits is excessive, especially for smaller communities with population under 10,000. Moville, for example is currently about one square mile. There is very little chance that future growth will necessitate expanding the city limits even 1 mile in any direction. Adding 2 miles in each direction would result in a 5 mile by 5 mile area of 25 square miles. I would support a 1 mile setback from City Limits.

- In reading through the ordinance as a whole could we add some type of language while you guys are updating this that in Section 7. Discontinuance/Decommissioning C. That if the City of Sioux City were to annex land that would include a wind energy system or wind farm that is over the 100 kWh. That Woodbury County would transfer the cash, an irrevocable letter of credit, or a performance bond running in favor of the County or municipally that the land falls under their jurisdiction at the time of Discontinuance/Decommissioning in which the wind energy system center point is located. For remediation/discontinuance/decommissioning and would be updated every five years.
- Also, the Four feet seems shallow in removal depth.
 - Could we add this for any solar ordinance you may also have?
- I have a feeling this ordinance change is being added to address shadow flicker. Does the county want to add some type
 of computer modeling stipulation into the ordinance where it could be shown that property or residence would not be impacted
 by the shadow flicker. The impact would be less on the south side then to the north, west, and east. Just a thought. In addition
 to noise decibels fall off after 1000 feet is pretty minimal for wind turbines.
- Also, this seems be written for the horizontal windmill style wind energy systems, what about vertical axis wind turbines? The setback might not fit for these if we were to ever get any.
- How was the city two-mile setback which is our jurisdiction limit for review picked?
- It might need to be laid out that pure power rating of these would be kW or MW but for machine output then it would need to be kWh or MWh. Not sure if that should or needs to be spelled out in the size of these wind energy systems or better clarified.
 - It might be a good idea in Section 5.3 that there is some spelling out that the if there is not director that his or her
 deputy have the ability to review the proposed construction documents.

AN ORDINANCE AMENDING PORTIONS OF WOODBURY COUNTY ORDINANCE #56: AN AMENDMENT TO MODIFY SECTION 6.1.A: WIND TURBINES SET BACK REQUIREMENTS TO INCREASE CERTAIN SETBACK REQUIREMENTS IN THE ORDINANCE REGULATING COMMERCIAL WIND ENERGY CONVERSION SYSTEMS IN UNINCORPORATED WOODBURY COUNTY.

NOW, THEREFORE, BE IT ENACTED BY THE BOARD OF SUPERVISORS OF WOODBURY COUNTY, IOWA THAT THE BELOW AMENDMENTS BE MADE:

AMENDMENT #1:

On page 10, Section 6.1.A, to repeal and replace the Wind Turbine Set Back Requirement for the City Limits Protected Area from 600 feet to 2 miles.

MidAmerican Comments: Under lowa Code Section 414.23, municipalities are granted the power to extend by ordinance into unincorporated areas up to two miles beyond the limits of such city, except for those areas within a county where a county zoning ordinance exists. Iowa code also mandates that a municipality must increase the size of its planning and zoning commission by two members and property owners within the affected area have the rights of hearing, protest, and appeal. Because Woodbury County has adopted a zoning ordinance within the unincorporated areas of Woodbury County surrounding several municipalities, these municipalities cannot exercise extra-territorial zoning.

During the development of a wind project, MidAmerican considers the growth of municipalities when siting turbines. This is an act of balancing the individual rights of landowners who have chosen to participate in a wind project and recognizing municipality land requirement to continue growth.

MidAmerican Suggestion: MidAmerican would suggest enacting a setback of 1-mile from city limits to balance the interests of rural landowners who wish to participate in a wind project and to allow municipalities room for potential growth.

AMENDMENT #2:

On page 10, Section 6.1.A, to repeal and replace the Wind Turbine Set Back Requirement for the Public Conservation Protected Area from 600 feet or 110% of total height (whichever is greater) to 2,640 feet or 4.5x tower height (whichever is greater).

MidAmerican Comments: MidAmerican recognizes the necessity for responsible siting of wind turbines, especially as it pertains public conservation areas. MidAmerican would see no problems with extending the required setback from public conservation areas from 600 feet to 2,640 feet or 4.5x tower height.

ITEM R3. Little Sioux Park Septic - ARPA Funds

Dan reported on his request to the Board of Supervisors for additional ARPA funds for a wastewater treatment system at Little Sioux Park. They granted an additional \$279,000 of ARPA funds for the increased costs of a wastewater treatment system, in addition to the original \$800,000 committed to the campground water and sewer project. Dan reviewed the two options which are a 2–3-acre retention pond or an enclosed tank system, such as the system available from BioMicrobics. The engineers recommend going with the enclosed tank system, and the DNR supports it for the park. If a retention pond is used, it would need to be permitted under Chapter 64 with the DNR which would delay construction for a year and a half. The ARPA funds need to be expended by 2025 which may not be possible with a retention pond.

(Tom arrived at 4:13 p.m.)

Neil requested that Dan call and/or visit at least two other campgrounds utilizing this system. Dan stated that this newer system would have less liability, no need for fencing, no certified operator requirement, and minimal maintenance. It would need to be pumped out annually, and the motor will eventually need to be replaced. Brian added that when the system discharges to the leach field, it is clean water. It has lifetime media in it and no filters. It does have a fan that will need to run during operation but can be shut off when the campground is closed. The Bio Microbics representatives recommended a 10,000-gallon tank which will provide plenty of capacity for future expansion.

Dan, Brian, and Nate met to plan the campsite layout for Bellamy campground. Bellamy currently has 40 sites which are very short and cannot accommodate most campers today. They were able to lay out 28 angled sites that are about 60' long. Tyler will go down with GPS to map it out. Dan told the engineering firm that they don't need to design the campground which will lower costs.

Dan discussed the possibility of delaying the septic work at Southwood if there aren't enough funds available. Delaying the playground replacement at Brown's Lake was also mentioned but may not be feasible due to the condition of the playground, which will be discussed later.

(Chris arrived at 4:30 p.m. and assumed the duties of chairperson.)

Dan anticipates an increase in revenue of \$30,000-38,000 with the extra \$5/night for each full-hookup site. He also noted that usage will likely increase because sewer hookups are available. Dan stated that the Correctionville city clerk, who is also a business owner, sent an email to each of the supervisors about the impact that Little Sioux Park has on the city of Correctionville. She said that when the beach was closed and usage was down, they noticed the impact.

ITEM R5. Capital Improvement Projects Update

1. Nature Center Shelter & Restroom

The shelter kit is on its way and will arrive by the end of the month. The contractor for the restroom project is also erecting the shelter. They will be showing up tomorrow or Monday to look at the project site to see how things have settled and how much dirt needs to be moved. The pad was intentionally overbuilt to accommodate settling. They will cut it down, pour concrete and then set up the shelter.

The contractor will start on the restroom next week. The biggest issue will be to coordinate with CW Suter for the plumbing and Williams for the electrical. They are aware that this is a busy time at the nature center with educational programs.

Neil asked about the plan for stabilizing the slope. Dan explained that when the retaining walls are taken out for the foundation project, the dirt that is cut down will go over the edge and will be

sloped down towards the nature center, the woods, and the retaining walls. It was suggested that the new retaining wall be extended to the shelter. Dan will look into the cost of dirt versus extending the retaining wall.

2. Nature Center Foundation & Retaining Walls

Dan reported that additional issues have been found that weren't noticed on the initial inspection of the nature center foundation problem. Theresa found a half-inch gap in the library between the bookshelf/counter and the outside wall. The library door frame is also bending.

The contractors think they can just polyjack it to take care of the problem, because they don't think it is a foundation issue. Dan thinks they will need to do pillar work. Terry Glade with CMBA, the original architect, is coming out to meet with Kenny Schmitz, the two floor-jacking companies, Dan, and Brian next Tuesday meeting. Dan will make sure they do due diligence.

Additionally, the sidewalk is pulling away from the building, and the water feature railings are leaning. The water feature repairs will come from the WCCB budget since it is not part of the foundation project. The three levels will be eliminated, and water won't be directed through the wall, but will just have one drop. The moving water is important as the sound attracts birds and animals.

Drainage is also being added by the dog-friendly fountain. A grate will be added and concrete poured around it. This will help with the water coming down the hill toward the building.

c. Naturalist II Position

Dan stated at the last board meeting that they were ready for naturalist II interviews, but two candidates withdrew their applications for various reasons leaving only one. Dan opted to open it up again with a deadline of April 7th or until filled. Six applications were received, and four were chosen to interview on the April 24th.

He also noted that positions for concession stand workers and summer security guards are open until Friday, and the part-time office assistant application deadline is April 21st. The resource technician position will be posted soon also.

d. Old Business

Budget Amendment for Motor Vehicles

Dan updated board members that he will be submitting a budget amendment for the restricted reserves carried over from last year's budget upon approval of the board of supervisors to cover two vehicle purchases in the amount of \$72,511. This was approved at previous board meeting.

• Technician Position at Southwood

Dan reported that a motion was made by a supervisor to withdraw approval of the new technician position at Southwood. Dan called each supervisor prior to the supervisors meeting to reinforce the need for the position. He also gave a presentation at the meeting, and the motion failed for lack of a second. He expressed appreciation to Mark Nelson for

the supervisors' support. This position will be advertised soon and interviews will be done in time to start someone shortly after July 1st.

e. Other Business

Dan stated that Supervisor Nelson had approached the board regarding setback limits for wind turbines, but the board never took a formal stance on it even though there was discussion and consensus. Mark stated that there will be three hearings for the ordinance change, with the first being on May 9th. They are looking for resolutions supporting their recommendation of a setback of a half mile or 4½ times the tower height, whichever is greater. The ordinance will include a waiver process to allow requests to shorten the setback to come before the supervisors, but there are certain things that will not be subject to having a variance granted, such as conservation areas, cemeteries, rights-of-way, and property lines. He talked to the MidAmerican representative for Woodbury county and was told that as a policy MidAmerican wants to stay away from conservation areas and towns, but there is nothing binding and there are also two other companies working in the area. MidAmerican has no concerns with this ordinance. Dan reiterated that he wants to keep the good partnership with MidAmerican. Dan read an email request he had received from Dan Priestly regarding the ordinance.

Theresa reported on the following Nature Center activities:

- The programs and visitors report for March was presented.
- The programs schedule is full of field trips beginning next week and through the end of the school year. There is a wait list for groups which cannot be accommodated. Many are from outside of the county, so Theresa is keeping track to make sure the Woodbury county schools are reached. The scheduling process may need to be adjusted in the future. Schools outside of Woodbury county pay \$1/child with \$15 minimum. Theresa would like the board to review this pricing, as well as the nature center room rental fees. Rental rate information is being collected from surrounding counties.
- The big bluestem root bundle has been received.
- The designers at BrownKnows Designs are working on a scale model of the screech owl aviary. Both the aviary and the root bundle should be installed by the end of June.

- Theresa is working on the Nature Calls committee volunteers list. Sponsor packets (letters, envelopes, and a digital letter to email) will be ready soon. She will send board members an updated list before finalizing the packets.
- The Nature Calls event will be held at the convention center again this year. They are trying to keep costs close to what it was last year.
- Offer letters have been sent to interns, and they are set to start on May 22nd. The AmeriCorps intern came in to fill out paperwork yesterday.
- Theresa and Kari did a Project Wild and Aquatic Wild session with 30 teaching students at Morningside. Theresa will also be doing a session at Briar Cliff.
- The volunteer clean-up day is April 22nd (Earth Day).
- The volunteer recognition event will be on May 18th with grilled hotdogs and popcorn.
 Unfortunately, Mark Peterson will not be able to attend, but Karen South will be there.
- Summer camp registration began last week for Foundation members, and numbers were way down. However, general registration opened yesterday, and camps are now 67% full with 150 kids registered.
- Mark Nelson complimented the social media posts about the union bridge and the eagle. He
 noted that whenever you put a spotlight on local parks, the people in that area will share it,
 giving extra exposure. Theresa asked members to thank the local Audubon and camera club
 people for sharing their photos.
- Next week is national volunteer week. Social media posts will highlight volunteers.

3. Park Activities

Brian reported on the following park activities:

- This is the busiest time for field staff, getting campgrounds ready and doing burns. Brian commended the WCCB field staff for always knowing what is needed and getting it done.
- Small burns have been done in the parks, and plans are underway for bigger burns at Oak
 Ridge Unit 1, the Breise property, and Owego. Brian will ensure there will be enough staff,
 equipment, and water for those burns.
- As of now, the cooperative burn week is still on for the last week of April. Pottawattamie county is now in a burn ban, and Harrison county might also be in a ban by then. More burns will be done in Woodbury county if not in a ban and the others still are.
- The Conex container in place at Brown's Lake but waiting on the electrician.
- The fence is being installed on the Brown's Lake beach tomorrow.
- Brown's Lake and Snyder Bend staff have also been doing playground repairs and installing some new slides. There is some cracking around bolt holes, paint peeling on posts, and metal exposed where the plastic coating has worn off steps and platforms. Equipment was installed over 25 years ago and should be replaced soon.
- Mark Nelson asked if information is included in campground kiosks about amenities in nearby towns. He suggested working cooperatively with those towns to list nearby restaurants, stores, etc., and build alliances with those towns.
- Brodie Skinner is graduating from the Iowa Law Enforcement Academy on April 21st. Dan, Brian, and Erik will attend to support him.

1. Brown's Lake Beach and Concessions

Took a walk to look at the concession stand.

Reviewed activities at Brown's Lake. Will be doing interviews for the concession. Finished small burn at Sheriff's office – Prairie Hill. Burned about 640 acres at Oak Ridge and Little Sioux. Balance park stuff with Owego. Burned 540 acres at Owego while it was dry this year. Working with forb gardens to put out there. 1,000 plugs growing here. Different species to diversify out there. Mostly forbs right now.

A lot of moving parts that are coming together. Interviewing for staff next week. POS using Square best percentage per swipe, user friendly. Targeting holiday weekend, but may not happen.

2. Little Sioux Park Renovations

Three acres of trees were cleared. Mark got a call that they are cutting all of the trees in the park. Ended up with 400 logs to go to the pallet makers. Had a little time left, and we wanted big rocks hauled to parking lot. Going to talk to Darren (Holly Brown) to haul the rock. North end of Little Sioux where they are doing the mining. Two phone calls from the Record, and they are going to write an article about the tree removal being for safety. It's graded, and they will get it seeded. See it next month when meeting is there.

3. Nature Center Shelter & Restroom

Found out shelter got pushed back to May 26th so Theresa will have to contact MRHD and ask for an extension. Supposed to have been here in April.

Discussed retaining wall. Poured wall behind shelter...will look like rock as the Little Sioux beach wall. They will start on it next week: Then it will be backfilled and they can pour the pad for the shelter.

Started restroom. Tore everything off the walls, got ready for plumbing, built the wall dividing the coat room. Brian had an idea to put a door into the nature center, so had them frame that up. plumbers will come in Tuesday. Electrician will drop heat into the room. Electrician will come in and do the lights.

4. Nature Center Foundation & Retaining Walls

Had two more meetings, last one was with certified testing services. Put a proposal into Kenny to do a floor survey. Couldn't understand why there is such a drop in the floor and no cracking outside and building is square. Do a survey and see where the drops are. \$950 Then they can tell where they have to do their soil borings. They don't think it is foundation so probably won't have to bring their big trucks in.

Retaining walls may come back on us if they don't need to take them out for access.






LOCATION MAPPING (Approximations). Revision to All Maps from Previous Reports


AMENDMENT #1:

On page 10, Section 6.1.A, to repeal and replace the Wind Turbine Set Back Requirement for the City Limits Protected Area from 600 feet to 2 miles.

AMENDMENT #2:

On page 10, Section 6.1.A, to repeal and replace the Wind Turbine Set Back Requirement for the Public Conservation Protected Area from 600 feet or 110% of total height (whichever is greater) to 1 mile.
