

Dear Ms. Samaniego:

On April 20, 2010, the Woodbury County Board of Supervisors approved a resolution for a tax suspension on your property at 3700 – 28th Street, Lot 479

According to the Iowa Code Section 427.9 the County Board of Supervisors shall annually send to the Department of Human Services the names and social security numbers of persons receiving a tax suspension. Department of Human Services shall verify the continued eligibility for tax suspension. Your name has come up as no longer eligible for a tax suspension. In order to continue your tax suspension on your property, we are requesting that you fill out the enclosed document and **if you are currently receiving federal supplementary security income (SSI) or state supplementary assistance, please send copies of the statement showing your benefits and any other proof of income along with your form to the Board Administration Office.**

Please have all information to the Board Administration by February 13, 2014. If this office does not receive all documentation requested, it will be on the next Board of Supervisors meeting to have the tax suspension lifted and your taxes will be due at that time.

1995 Schult Homes 76x16 Beige


