## Changes to Iowa Veterans Benefits This Year

- The new Armed Forces Hunting and Fishing licenses are now available to residents of Iowa who serviced in the armed forces of the United States on federal active duty. The new annual hunting and fishing license is \$5 with a \$2 processing fee. To qualify, Veterans will need to submit a one-time application with a copy of their DD 214. To apply you can stop by our office.
- Governor Kim Reynolds signed a new property tax law on May 4th. With the new law, the military service property tax exemption and credit increased from \$1,852 to \$4,000, starting with the assessment year beginning on Jan 1, 2023. The exemption is available to "an honorable separated, retired, furloughed to a reserve, placed on inactive status or discharged Veteran." To make sure you are signed up for this benefit, please stop by the county assessor's office with your DD 214.

## Eligibility for VA Disability Benefits

Review VA disability benefits eligibility criteria to find out if you can get disability compensation for an illness or injury that was caused by—or got worse because of your active military service. Compensation may include financial support and other benefits like health care.

### Eligibility for VA disability benefits

You may be eligible for VA disability benefits or compensation if you meet both of these requirements.

#### Both of these must be true:

- You have a current illness or injury (known as a condition) that affects your mind or body, **and**
- You served on active duty, active duty for training, or inactive duty training

#### And at least 1 of these must be true:

- You got sick or injured while serving in the military—and can link this condition to your illness or injury (called an in-service disability claim), **or**
- You had an illness or injury before you joined the military—and serving made it worse (called a preservice disability claim), **or**
- You have a disability related to your active-duty service that didn't appear until after you ended your service (called a post service disability claim).

### Presumptive conditions

For some conditions, we automatically assume (or “presume”) that your service caused your condition. We call these presumptive conditions. If you have a presumptive condition, you don't need to prove that your service caused the condition. You only need to meet the service requirements for the presumption.

## Iowa Veterans Trust Fund

The State of Iowa established a multi-million-dollar fund to provide certain services to Veterans. Interest from this fund has been available to provide relief for Iowa Veterans and their families. Currently, funds are used for unemployment or underemployment assistance due to service-related causes, assistance with vision, hearing, dental care, durable medical equipment and prescription drugs; counseling and substance abuse services; emergency vehicle repair; housing repair; and transitional housing in an emergency. Trust fund expenditures are approved through the Iowa Veterans Commission. Application is based on income and circumstances. To learn more, please contact our office.

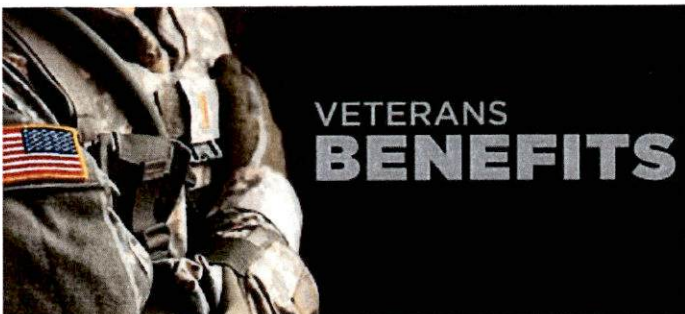
**Greetings From Our Office**
