WHEREAS, pursuant to notice published as required by law, this Board has held a public meeting and hearing upon the proposal to institute proceedings for the authorization of a Loan Agreement and the issuance of not to exceed \$900,000 General Obligation Capital Loan Notes, Series 2014B, for the purpose of paying costs of construction, reconstruction, improvements and repairs or equipping of bridges, roads and culverts which assist in economic development which creates jobs and wealth, and has considered the extent of objections received from residents or property owners as to the proposal and, accordingly the following action is now considered to be in the best interests of the County and residents thereof:

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF WOODBURY COUNTY, STATE OF IOWA:

Section 1. That this Board does hereby institute proceedings and take additional action for the authorization of a Loan Agreement and issuance in the manner required by law of not to exceed \$900,000 General Obligation Capital Loan Notes, Series 2014B, to evidence the obligation thereof for the foregoing purpose.

Section 2. This Resolution shall serve as a declaration of official intent under Treasury Regulation 1.150-2 and shall be maintained on file as a public record of such intent. It is reasonably expected that moneys may be advanced from time to time for capital expenditures which are to be paid from the proceeds of the above loan agreement. The amounts so advanced shall be reimbursed from the proceeds of the Loan Agreement not later than eighteen months after the initial payment of the capital expenditures or eighteen months after the property is placed in service. Such advancements shall not exceed the loan amount authorized in this Resolution unless the same are for preliminary expenditures or unless another declaration of intention is adopted.

An Invitation to Dialogue

During my last 30 years of public service on boards and commissions, I have come to the conclusion that any board functions best when its members have open communication and are working as a team. Excuse me in advance if this seems preachy. It is not meant to, but I think I have earned the right to make a few observations and offer an invitation. I am not talking about always agreeing, that is not possible and frankly it may be harmful. Leaders sometimes need to disagree and coming to a final solution, is often tedious and messy. That is Democracy!

While disagreement may be healthy, individuals need not be "Disagreeable." Members of a team must feel like other team members share common goals even if the objectives are somewhat different. Specifically, team members should never feel "Ambushed," or "Threatened" by another elected official.

To that end, I am proposing as I leave the Board, that there be a mediator appointed to facilitate a focused conversation regarding a protocol for problem solving as a team. I envision this to be the first step in attempting not to have unanimous decisions, but to walk away from meetings knowing that methods and objectives may vary but each member has a common goal of Serving Woodbury County, and treating other team members with respect and dignity.

The County Board should be the role model for this community on how adults interact and deal with serious problems. If we are going to have future leaders understand teaming, and the value of public service we need to begin modeling it now. In short, we need to forget campaigning and begin governing!

PSYCHOLOGICAL VIOLENCE . EMOTIONAL ABUSE AT WORK . MOBBING


Workplace Bullying remains an American epidemic. In the absence of legal prohibitions against it, employers are failing to take responsibility for its prevention and correction. Bullied individuals pay dearly with the loss of their economic livelihood to stop it.

PREVALENCE

Workplace Bullying was defined as repeated mistreatment; abusive conduct that is: threatening, humiliating, or intimidating, work sabotage, or verbal abuse.

WORKPLACE

This definition is the one used in the Healthy Workplace Bill. Bullying is "abusive conduct," referring to its most serious forms only. By comparison with the rate of any disease or malady. bullying is an epidemic.



The number of U.S. workers who are affected by bullying – summing over those with direct bullying and witnessing experiences – is 65.6 million, the combined population of 15 states.

EMPLOYERS

Employers fail to appropriately react to abusive conduct much more frequently than they take positive steps ameliorate bullying. Denial and discounting were the most common reactions by employers.

This led to 61% of the targets losing their jobs as the only way to stop the bullying.

How Long Does It Take: This Preliminary Application will be reviewed by Woodbury County to make an initial determination of the viability of the application request. This initial determination will take approximately 2 weeks from the submission of a fully completed Preliminary Loan Application. If viability of the project is determined, the Preliminary Loan Application will be forwarded to the Siouxland Economic Development Corporation (SEDC). Applicant will be charged a loan review fee (\$350 non-refundable) required by SEDC. The SEDC Board meets on the third Wednesday of each month, at which time the SEDC will provide its recommendation to Woodbury County. The loan review fee is non-refundable.

Loans will not be available under this program for residential structure, or solely for the purpose of rehabilitation of existing business structures, or merely to refinance an existing loan, or for purely passive business ventures. Loans could, however, be provided to a developer who plans to build or improve a commercial structure if the developer has solid commitments from otherwise qualifying businesses to lease space in the facility.

Loan Criteria: Will consider number of jobs created, whether the business will add tax base to the county, adequacy of loan security (when applicable), credit risk of applicant, and general business plan. Business may include on-farm or off-farm agricultural businesses, service related businesses as opposed to strictly non-food related retail businesses (unless retail business serves existing activity in community), and general need for the business in community (example: grocery store, gas stations, and the like).

Fees: No fee for submission of Preliminary Loan Application. If Woodbury County deems viable application, then the SEDC review fee will be set at \$350 and is non-refundable.

Processing Fee: Variable, depending upon security offered.

Servicing Fee: Annual fee of 0.5% of declining balance charged by SEDC.

Closing Costs: Closing costs are responsibility of the borrower.

Hawkeye Clinic of Sergeant Bluff

DBA: Sergeant Bluff Eyecare

Sergeant Bluff Eyecare Is a growing optometric clinic in the Pioneer Flats subdivision of Sergeant Bluff. It is a medical based eye clinic with the latest technology in advanced detection and monitoring of all ocular diseases, namely, the top three causes of blindness in the US, macular degeneration, glaucoma and diabetes. It also includes retail sales of spectacles and contact lenses. The clinic has regular patients from over 90 communities and from 11 states.

It began in 2007 and is currently owned and operated by optometrist, Ben Uhl. Besides a one year deployment to Afghanistan from 2010 through 2011, Dr. Uhl has been the sole optometrist practicing since he graduated 2008. He became the sole owner in 2014. He was honored with the Young Optometrist of the Year from the Iowa Optometric Association in 2012 and by the Northwest Iowa Area Education Agency with the Friends of Preschool award for work with Siouxland area children and their vision. He was recently named one of the Top 10 Under 40 in Siouxland by Siouxland Magazine.

There are three full time staff and two part time staff. There would be two new positions available once the new building is operational.

Sergeant Bluff Eyecare currently leases space in a strip mall and requires more space for exams, medical equipment rooms, frame displays and storage. The need stems from the rapid growth of both retail sales and medical eye care. The "Invest in Woodbury County" loan would provide funds to build a stand-alone 7,000 square foot building nearby and would more than double the size of the current clinic and provide separate lease space of 3,000-4,000 square feet. This space could potentially serve as future expansion if necessary. There will be dedicated rooms for additional technology Patient capacity will expand from two exam rooms to six in anticipation of adding a second optometrist in the near future.

There currently are two local businesses that have shown interest in relocating to the new lease space. We are in the process of determining the details of the lease, but an initial estimate would be \$1.00 per square foot. The total investment for the building alone will be about \$1.2 million and about \$100,000 in medical equipment to furnish it.

Sergeant Bluff Eyecare is important to the community because of the support it provides to local organizations and positive impact it has on its residents. This loan is important for the Sergeant Bluff community because, as one of two medical clinics in Sergeant Bluff, it will provide incentive to keep a growing optometric practice local to Sergeant Bluff.

WHEREAS, Chapter 15A of the Code of Iowa ("Chapter 15A") declares that economic development is a public purpose for which a County may provide grants, loans, tax incentives, guarantees and other financial assistance to or for the benefit of private persons; and

WHEREAS, Chapter 15A requires that before public funds are used for grants, loans, tax incentives or other financial assistance, a Board of Supervisors must determine that a public purpose will reasonably be accomplished by the spending or use of those funds; and

WHEREAS, Chapter 15A requires that in determining whether funds should be spent, a Board of Supervisors must consider any or all of a series of factors;

NOW, THEREFORE, It Is Resolved by the Board of Supervisors of Woodbury County, Iowa, as follows:

Section 1. Pursuant to the factors listed in Chapter 15A, the Council hereby finds that:

(a) The CF Industries Project will add diversity and generate new opportunities for the Woodbury County and Iowa economies;

(b) The CF Industries Project will generate public gains and benefits, particularly in the creation of new jobs, which are warranted in comparison to the amount of the proposed property tax incentives.

Section 2. The Board also finds that a public purpose will reasonably be accomplished by entering into the Agreement and providing the property tax payments to the Company.

Section 3. The Agreement is hereby approved and the Chairperson and County Auditor are hereby authorized and directed to execute and deliver the Agreement on behalf of the County, in substantially the form and content in which the Agreement has been presented to this Board of Supervisors, and such officers are also authorized to make such changes, modifications, additions or deletions as they, with the advice of bond counsel, may believe to be necessary, and to take such actions as may be necessary to carry out the provisions of the Agreement.

Section 4. As provided and required by Chapter 403 of the Code of Iowa, the County's obligations under the Agreement shall be payable solely from the income and proceeds of the Urban Renewal Tax Revenue Fund.

Section 5. The County hereby pledges to the payment of the Agreement the Urban Renewal Tax Revenue Fund and the taxes referred to in Subsection 2 of Section 403.19 of the Code of Iowa to be paid into such Fund.

Section 6. After its adoption, a copy of this resolution shall be filed in the office of the County Auditor to evidence the continuing pledging of the Urban Renewal Tax Revenue Fund and the portion of taxes to be paid into such Fund and, pursuant to the direction of Section 403.19 of the Code of Iowa, the Auditor shall allocate the taxes in accordance therewith and in accordance with the tax allocation ordinance referred to in the preamble hereof.

Section I—RFP Overview

A. Purpose

Woodbury County is taking bids for a Telephone System to be housed at the Trosper Hoyt Building located at 822 Douglas Street Sioux City IA. This RFP is looking for available vendors to provide a system to support the Department of Human Services (DHS) office located within the Trosper Hoyt facility and decommission legacy systems.

B. RFP Objectives

Through this Request for Proposal (RFP), Woodbury County is soliciting proposals to accomplish the following objectives:

- a. Contract with one vendor to provide a new traditional digital Telephony System, handsets and related ancillary equipment for approximately 125 DHS personnel located in the Trosper Hoyt building in downtown Sioux City IA.
- b. Winning vendor will decommission, remove and dispose of existing Nortel telephone system(s), handsets and related telephony equipment associated with the legacy system facilities at Trosper Hoyt (822 Douglas Street), Law Enforcement Center (LEC - 407 7Th Street) and Siouxland District Health (SDH- 1014 Nebraska St.)
- c. Winning Vendor will provide a central point of contact for DHS personnel for break/fix items associated with new system and provide remote management utilities for IT personnel.
- d. Winning vendor will supply monthly T1-usage and statistic reports to be delivered via email to, Network Manager, County Telco Technician and Administrative Assistant. Or, provide capability of for IT personnel to generate same reports with minimal manual intervention.

C. General Conditions

This RFP is not an offer to purchase. Acceptance of a proposal neither commits Woodbury County to award a contract to any vendor, even if all requirements stated in this RFP are met, or limits our right to negotiate in our best interest. WCICC-IT, on behalf of Woodbury County Board of Supervisors (BOS), will examine each proposal for best price, timeliness of integrating new system and de-installing legacy systems, reference checks and value-add components the vendor can provide. If in the best interest of Woodbury County, the County reserves the right to split the award between two vendors. For example, the complete new system may be awarded to Vendor A and the decommissioning of the legacy systems may be awarded to Vendor B.

Proposals are to be made in good faith, without fraud, collusion or connection of any kind with any other contractor for the same work. All bidders must complete in their own interest and in their own behalf. The vendor will absorb all costs incurred in the preparation and presentation of the proposal. All vendors who submit proposals will be notified of the results of the selection process.

Proposals will be opened and considered for award at a public meeting of the Woodbury County Board of Supervisors. Woodbury County reserves the right to reject any or all proposals, in whole or in part, with or without cause, even if all the stated requirements are met. At the sole discretion of Woodbury County, bidder presentations may be requested before award of the contract.

Subcontractors working for the vendor must be identified in the RFP and must meet all the requirements of the RFP and any contract between the vendor and the subcontractor must include all contract terms agreed to between Woodbury County and the successful vendor.

D. Confidentiality

The RFP and any attached documents are public records once submitted to Woodbury County. Any information contained in the proposal that is proprietary must be clearly marked as such and will be treated as confidential to the extent allowable in the State of Iowa Code.

E. Warranty and Maintenance Terms

For the purpose of this RFP, any warranty and maintenance period will be for 36, 60 or 84 months with 12 month renewal option terms provided thereafter.

F. Proposal Effective Period

Vendors should state in writing that all furnished information, including prices, will remain valid for 90 days from the date of the deadline for submission of this RFP.

G. Evaluation Criteria

This RFP is a subjective evaluation process that reviews all proposals to determine which proposal provides the best value for the Woodbury County. Evaluation criteria may include, but may not be limited to, the following:

- 1. Competitive pricing
- 2. Total time needed to acquire, install and train on new system and de-install legacy systems
- 3. Reference check and vendor value-add items

H. Bid Bond and Proof of Insurance

Vendor shall take out and maintain during the life of the project Comprehensive General Liability Insurance in the minimum amount of \$500,000. Proof of insurance shall be submitted with the Proposal.

Each Proposal must be accompanied by a separate sealed envelope containing Bid Security in the form of a Cashier's Check or Certified Check, or a Bid Bond executed by a corporation authorized to act as surety in the State of Iowa. 



Exhibit 2. (System located at SDH #1)

B. Scope of Services

Woodbury County seeks a vendor whom can provide a new digital telephony solution and de-install legacy telephony systems in a timely and efficient manner.

West of Hamilton: The I-29 Section 1 Zenith Drive project will consist of full reconstruction and utility relocations beginning at the west end of Zenith Drive and continuing east to Hamilton Boulevard. The full reconstruction will include new sanitary sewer, storm sewer, water main, street pavement, curb, and gutter within the City right-of-way. The project is expected to bid in November or December 2014 and be completed by late fall 2015. A temporary access road will be provided for access to the west end of Zenith Drive and trenchless construction methods for the sanitary sewer will be used to keep various commercial access drives open during construction.

East of Hamilton: The I-29 Section 1 Zenith Drive project will consist of full reconstruction of Zenith Drive west of Hamilton, but also includes new water main north of Tri-View along the east side of Hamilton and sliplining of a smaller water main within the existing water main south of Tri View along the east side of Hamilton. The work will occur in the area of the existing water main. The project is expected to bid in November or December 2014 and be completed by late fall 2015. The construction will not detour traffic on Tri View Avenue.

In connection with the Zenith Drive Improvements Project, it is necessary for the City to acquire a Temporary Construction Easement and a Permanent Utility Easement on the property located at 1211 Tri View Avenue AND 1221 Tri View Avenue. Copies of the easement plats showing the areas of the easements are enclosed.
