In the Lawton-Bronson Community School District, the following Revenue Purpose Statement which specifies the use of the sales, services and use tax funds from the State of Iowa secure an advanced vision for education fund for school infrastructure (penny sales, services and use tax for schools) shall be adopted:

To provide funds for property tax relief.

To provide funds to build and furnish a new school building or buildings; to build and furnish addition(s) to school buildings in the District; to remodel, repair, expand, and improve the school buildings in the District; to purchase and improve grounds; for demolition work; to furnish and equip district facilities.

To provide funds for the purchase, lease or lease-purchase of buildings, equipment (including transportation and recreation equipment), or technology, as authorized by law, to implement energy conservation measures, sharing or rental of facilities, procuring or acquisition of libraries, or opening roads to schoolhouses or buildings.

To provide funds for emergency repairs to respond to natural disasters, such as fire, wind damage, flood; unanticipated mechanical, plumbing, structural, roof, electrical system failures; environmental remediation; or to respond to changes in demographics that require construction of additions or improvements to school buildings or new school buildings.

To provide funds to establish and maintain public recreation places and playgrounds; provide for supervision and instruction for recreational activities; or for community education purposes; and other authorized expenditures and purposes as now or hereafter permitted by law and designated by the Lawton-Bronson Community School District.

To provide funds for the payment of principal and interest or retirement of general obligation bonds issued for school infrastructure purposes, energy improvement loans, loan agreements authorized by Iowa Code section 297.36, sales, service and use tax revenue bonds issued under Iowa Code section 423E.5.

It being understood that if this proposition should fail to be approved by the voters, such failure shall not be construed to terminate or restrict authority previously granted by the voters to expend receipts from the secure an advanced vision for education fund.

Roger and Jean Hassebroek have filed a subdivision application and final platting for a rural Woodbury County parcel. The applicants intend to subdivide 8.09 acres into two (2) lots. The applicants currently reside on the parent parcel within one of the two existing single family dwellings. The applicants wish to subdivide the parcel into two lots in order to place each dwelling on an independent parcel.

The parent parcel lies within rural Woodbury County approximately 9/10 of a mile southwest of the Sioux City corporate limits. The closest intersection is ½ mile to the east at 235th St. and Allison Ave. Location mapping can be found on the attached final plat. The location is within a portion of the NE ¼ of the SW ¼ of Section 11, Liberty West Township.

The parent parcel is zoned GI (General Industrial); is not located within a special flood hazard area; and does not lie within any drainage district. The parcel is serviced by drives addressed 1020 and 1022 235th St. The current and proposed use of the parent parcel and its structures are classified as legal non-conforming uses within the GI zoning district designation and Woodbury County zoning ordinances.

As the use of the parent parcel is residential no CSR value for the parcel is unavailable. CSR values for congruent parcels range from 30.57 to 39.00. This range is below the threshold where county policy discourages subdivision platting approval.

The location is located along graveled right-of-way and will require the recording of a paving agreement pursuant to county paving policy as part of any final plat approval. Further the city of Sioux City can exercise its right to extraterritorial review and final plat approval.

WORDING FOR AGENDA ITEM: Approval of a resolution sunsetting the "Investing in Woodbury County" Loan Program

EXECUTIVE SUMMARY: We believe in the name of fairness and greater economic impact that the low-interest revolving Loan Program has fulfilled its purpose and should sunset. We are also cognizant that even in recent weeks, the county has been asked for contributions to economic development projects ranging from \$75,000 to \$2,000,000, and having funds from a revolving loan program already "tied up" for several years can present a hindrance to their full consideration. We believe the intent of Local Option Sales Tax (LOST) dollars for economic development is for the public good. Low-interest loans to private citizens for their own business expansions don't necessarily hurt Woodbury County, and they aren't necessarily bad decisions—but we believe they may not be the best decisions. Furthermore, it is misleading for us as a County Board to claim we have "created" one or a couple jobs when our loans are typically not the primary source of funds, but secondary, tertiary, etc... How do we know that part-time job (for instance) wouldn't already be created?

Five years after inception, and after the recession, we don't believe spending further tax dollars to advertise preferential loan terms to entrepreneurs is our place, especially considering Siouxland Economic Development Corporation's capable role in this area. Considering the county's income streams are very limited/inflexible, speculation should not be our role. *Loaning funds out below any bank's rate represents a loss to the taxpayers funding the loan*.

BACKGROUND: The Loan Program was created in 2010 after the 2008-2009 recession. Although \$1 million was intended, four loans have been approved, all at a 2% rate and totaling \$359,000. No loans were given out in FY 2014.

FINANCIAL IMPACT: We intend continued use of Local Option Sales Tax for economic development, but for public rather than private benefit. In accordance with the resolution's action to rescind commitment of \$400,000 in LOST funds to the Loan Program, LOST funds unallocated for FY 2016 would rise dramatically from \$151,653 to \$551,653.

The four current loans already begun will not be affected in any way and their repayments will still go to the fund established.

WHEREAS, the "Investing in Woodbury County" Loan Program was created by Resolution #10,691 on July 20, 2010 to benefit private business owners "and in order to offer local solutions to the national economic recession"; and

WHEREAS, a goal of up to \$1M in low-interest loans of 2% was established in a revolving loan fund, with current loan lengths ranging from 5-10 years; and

WHEREAS, Woodbury County appreciates the Siouxland Economic Development Corporation, which not only assists the county's loan program with screening and all loan recommendations, but manages a much larger private loan program, and therefore Woodbury County finds its own revolving loan program to be of diminished use; and

WHEREAS, Woodbury County's practice of being a partial lender gives no guarantee whether the low-interest loans they approve create jobs that would have otherwise already been created, or if taxpayers are comfortable with a limited number of businesses being granted loans below market rate, in some cases for business expansion rather than creation; and

WHEREAS, Woodbury County funding for economic development projects that service the public good over private interests are in high demand and will continue to be so;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF WOODBURY COUNTY, IOWA that the program created by Resolution #10,691 is eliminated; and

BE IT FURTHER RESOLVED that the action taken by the Woodbury County Board of Supervisors on Feb. 24, 2015 to allocate a total of \$400,000 of Local Option Sales Tax funds to the Loan Program is hereby rescinded.

BE IT SO RESOLVED this 15th day of September, 2015.
