#### **28E AGREEMENT**

BETWEEN WOODBURY COUNTY, IOWA, and the WOODBURY SOIL AND WATER CONSERVATION DISTRICT for FUNDING AND MANAGEMENT of a WATERSHED INSPECTION and MAINTENANCE PROGRAM in WOODBURY COUNTY, STATE OF IOWA

#### 1) **PURPOSE**

This Agreement is entered into between the County and the SWCD for the purpose of providing the terms under which the Parties agree to fund and manage a watershed inspection and maintenance program in Woodbury County as sponsors of the Little Sioux River Flood Protection Project. This project involves approximately 460 grade stabilization control structures which have been constructed with federal funds and local contributions since 1949. The Parties do not intend to create a separate legal entity under this Agreement.

#### 2) TERM

This Agreement shall begin on July 1, 2017, and terminate on June 30, 2018. The Agreement may be extended by the written agreement of all parties on terms stated therein.

#### 3) **ADMINISTRATION**

This Agreement shall be administered by the SWCD. All administrative decisions concerning this Agreement shall be undertaken pursuant to the terms outlined below.

#### 4) HOLDING OF PROPERTY UNDER THIS AGREEMENT

All real and personal property used or acquired under the terms of this Agreement shall be held in the name of the SWCD.

#### 5) **COUNTY RESPONSIBILITIES**

The County shall provide the SWCD with funds in the amount of Thirty-six Thousand Dollars (\$36,000.00), payable in installments of Twelve Thousand Dollars (\$12,000.00), due July 1, 2017; Twelve Thousand Dollars (\$12,000.00), due January 1, 2018, and Twelve Thousand Dollars (\$12,000.00) due June 1, 2018. Payments shall be sent to the SWCD office at 204 First Street, Ste C1, Sergeant Bluff, IA 51054. The funds provided to the SWCD by the County shall be used by the SWCD to employ individuals to inspect and maintain the watershed structures described in paragraph I of this Agreement. The individuals employed by the SWCD will record the condition of, and maintenance work performed on, each structure. Other related duties will be performed by the individuals employed by the SWCD, as outlined in a position description prepared for the position by the SWCD.

#### 6) **SWCD RESPONSIBILITIES**

The SWCD shall employ individuals to inspect and maintain the watershed structures described in paragraph I of this Agreement. The individuals employed by the SWCD will record the condition of, and maintenance work performed on, each structure. The SWCD shall supervise the individuals employed as employees of the SWCD, and shall indemnify and hold harmless the County for any negligence on the part of the individuals employed by the SWCD. The individuals employed by the SWCD will represent the SWCD in performing all types of watershed work.

#### 7) FINANCING

The SWCD shall pay all costs associated with the administration of this Agreement, except as provided in paragraph V of this Agreement.

#### 8) **AMENDMENT**

This Agreement may be amended from time to time by written agreement of the Parties. All amendments shall be in writing, signed by both Parties, and electronically

filed with the Secretary of State as required by Iowa Code section 28E.8 (2017).

#### 9) **TERMINATION**

The County may terminate this Agreement at any time with 120 days written notice to the SWCD. Upon termination of this Agreement, the Parties agree to use their best efforts to wrap up all operations undertaken pursuant to this Agreement. 



#### **EXECUTIVE SUMMARY:**

We, rural residents, are opposed to factory farms in rural Woodbury Co. These unregulated SAFO's (Small Animal Feeding Operations) and CAFO's (Confined Animal Feeding Operations) are being built in rural Woodbury County with minimal oversight and just under the number of animal units required to be regulated by the DNR. This allows developers to circumvent the laws in place to protect rural residents and our environment. These facilities affect our property values, air and water quality, and our families quality of life.

The State Ag Exempt rules and DNR regulations need to be changed to allow for:

- 1. Tougher requirements
- 2. Further separation distances from residences, public spaces, waterways and from other CAFO's, no matter the owner.
- 3. More county input
- 4. More time for counties and citizen's to review the application
- 5. Stronger oversight by the DNR

Iowa Citizen's for Community Improvement (Iowa CCI) has already sent all the Woodbury Co. Supervisors a letter encoraging you to represent your rural residents by writing letters of support to tighten regulations at the DNR, as well as appealing, on our behalf, to our state representatives. We encourage you to represent us and take this action.

#### **BACKGROUND**:

Two SAFO's are currently under construction in Grant and Wolf Creek townships, with another nursery pending in Banner Township. The SAFO's in Grant and Wolf Creek are hog nurseries that are being built for 480 animal units. Because these nurseries are under the 500 animal units (AU) required for DNR oversight, there are NO regulations for separation distances from residences, public land use, or waterways. The only restrictions are for surface intakes of drainage wells, wetlands, or right-of-way of thoroughfare. These nurseries can be placed within an arms reach of a residence, park, or another hog confinement.

This oversight, intended to protect citizens and our environment, includes completing the Master Matrix and submitting a manure management plan as well as adhering to certain separation distances. Without effective over sight we are at higher risk for ground water pollution from spreading manure in the highly erodible soils of Woodbury County's rolling hills. These facilities require large amounts of water which puts our wells and aquifers at risk. Our air quality is affected by the smell of these facilities and the increased fly population. As a result of all of the above, our property values will drop.

#### FINANCIAL IMPACT:

These factory farms receive tax breaks that other industries don't that aren't Ag Exempt, however, they significantly impact our rural roads. Seaboard Foods and Triumph Foods are large integrated pork producers that control production. If hog demand drops these small local developers who incured the costs to build these hog nurseries and confinements will still have the building costs to cover without the production to cover their costs. What benefit if that to the rural economy? The big companies get the profits while the local developers absorb the risks and local residents pay the costs.

The costs to rural residents include:

- 1. Degraded road surfaces are caused by the traffic related running an industrial-sized operation on rural gravel roads.
- 2. Rural residents maybe forced to dig new wells due to ground water pollution or depletion of acquifers.
- 3. Lower air quality from animal wastes, dead animals, and increased fly population.
- 4. Reduced quality of life for rural residence and exposure to toxins from animal wastes, along with other agricultural chemicals.

As a result of the above property values are reduc	ed. An UNI study estimates that	t the cost of these operations is	s 10% of property
values.

As rural residents, we recommend that the Woodbury Board of Supervisors educate themselves on these issues and represent our concerns by encouraging lowa legislators and the DNR to tighten up regulations related to CAFO's and SAFO's. These regulations are designed to protect rural residents and family farms. Factory farms like these should be classified as industry not agriculture, and placed in industrial areas with the appropriate infrastructure because of their large scale.

# JUVENILE DETENTION SERVICE AGREEMENT BETWEEN WOODBURY COUNTY, IOWA and THURSTON COUNTY, NE.

THIS AGREEMENT, entered this	day of	, 2017, by and
between Woodbury County, Iowa and Thurst	on County, NE.	

**WHEREAS**, Woodbury County agrees to allow Thurston County juveniles to be housed in the Woodbury County Juvenile Detention Center upon all the conditions set forth below.

**NOW THEREFORE, IN CONSIDERATION** of the mutual undertakings and agreements hereinafter set forth;

#### I. The Parties agree as follows:

- A. Thurston County agrees to all the following:
  - 1. Thurston County will contact the Woodbury County Juvenile Detention Center prior to the transportation of any juvenile to determine the current population and whether the alleged charges meet the criteria for admittance of the juvenile to the Woodbury County Juvenile Detention Center.
  - 2. Thurston County will provide twenty-four (24) hour transportation service for all its juveniles transported to and from the Woodbury County Juvenile Detention Center.
  - 3. Thurston County will provide all transportation for its juveniles for routine medical treatment, including but not limited to doctor's appointments, dentist appointments, and/or psychiatric or psychological evaluations.
  - 4. Thurston County will provide social information about the juvenile to the Woodbury County Juvenile Detention Center as is necessary to assist Woodbury County Juvenile Detention Center staff in providing services to the juvenile.
  - 5. Thurston County will pay all costs of evaluations, routine medical exams/treatments, medications, and evaluations not otherwise paid by the family, Title XIX, medical insurance, or Family Centered Services.
  - 6. Thurston County will provide the Woodbury County Juvenile Detention Center with court orders that contain the following information: All criminal charges, placement of the temporary care, custody, and control of the juvenile with the Director of the Woodbury County Juvenile Detention Center, and authorization for the Woodbury County Juvenile Detention Center to provide emergency medical care, including surgery.

- 7. Thurston County will pay the costs of any emergency medical care necessary for the juvenile that is not otherwise paid by the family, Title XIX, medical insurance, or Family Centered Services.
- 8. Thurston County will maintain contact with the Woodbury County Juvenile Detention Center case worker to track the progress of the juvenile.
- 9. Thurston County will provide any information about the juvenile that exist which indicates the juvenile is a danger to himself/herself or others.
- 10. Thurston County will remove any of its juveniles as requested by the Woodbury County Juvenile Detention Center within twenty-four (24) hours of notification for any reason unless otherwise authorized by the Director of the Woodbury County Juvenile Detention Center.
- 11. Thurston County will pay Woodbury County the rate of one hundred fifty (150) dollars per day for each juvenile placed in the Woodbury County Juvenile Detention Center. Thurston County will pay the one hundred fifty (150) dollars per day rate for the day of placement of the juvenile in the Woodbury County Juvenile Detention Center and the day of release of the juvenile from the Woodbury County Juvenile Detention Center. Thurston County will pay Woodbury County within thirty (30) days from the date of the bill.
- B. Woodbury County and/or the Woodbury County Juvenile Detention Center agree to all the following:
  - 1. Woodbury County will complete intake on all juveniles.
  - 2. Woodbury County will provide a report on the juvenile's overall conduct during his/her time in the Woodbury County Juvenile Detention Center when necessary.
  - 3. The Woodbury County Juvenile Detention Center will provide appropriate meals and snacks, sleeping facilities, personal hygiene products, and adequate clothing to the juvenile.
  - 4. The Woodbury County Juvenile Detention Center will allow two (2) telephone calls during the 7-3 shift and two (2) telephone calls during the 3-11 shift to immediate family members (parents and grandparents) by the juvenile unless otherwise authorized by the Woodbury County Juvenile Detention Center staff. Costs of long distance calls will be assessed to the juvenile.

- 5. The Woodbury County Juvenile Detention Center will allow the juvenile to have regular telephone calls and visits with his/her juvenile court officer, DHS worker, and attorney.
- 6. The Woodbury County Juvenile Detention Center will provide scheduled times for visitation with immediate family consisting in this paragraph as parents, grandparents, siblings, or children of the juvenile unless otherwise authorized and approved by the Woodbury County Juvenile Detention Center staff.
- 7. The Woodbury County Juvenile Detention Center will notify all necessary parties regarding serious medical or behavioral problems within twenty-four (24) hours of the occurrence excluding weekends and holidays.
- 8. The Woodbury County Juvenile Detention Center will provide the juvenile with crisis counseling.
- 9. The Woodbury County Juvenile Detention Center will provide the juvenile with educational and recreational services.
- 10. The Woodbury County Juvenile Detention Center will attempt to collect all necessary medical and other releases for information from the family and juvenile.
- 11. Woodbury County will bill Thurston County at the end of each juvenile's incarceration period in the Woodbury County Juvenile Detention Center.

#### II. Right of Refusal

The Woodbury County Juvenile Detention Center reserves the right to refuse acceptance of any juveniles anytime the staff deems the juvenile not appropriate for placement at the Woodbury County Juvenile Detention Center. The Woodbury County Juvenile Detention Center will not accept juveniles who are intoxicated, injured without a proper notice from a doctor that states he/she is safe for placement in the Woodbury County Juvenile Detention Center, or if the Woodbury County Juvenile Detention Center is at capacity. The Woodbury County Juvenile Detention Center will not accept a juvenile who has committed or has been alleged to have committed a criminal act not recognized as a criminal act by the State of Iowa.

All juveniles detained in the Woodbury County Juvenile Detention Center will be required to follow the policy and procedures of the Woodbury County Juvenile Detention Center. The Woodbury County Juvenile Detention Center has the right to have a juvenile immediately removed from the facility in cases of assaultive behavior on other residents or staff, if the juvenile attempts harm to himself/herself, if the juvenile conducts sexual misconduct, or if the juvenile's behavior places the juvenile, other residents or staff in danger. Thurston County agrees upon receiving notice for removal under any of the above

scenarios by the Woodbury County Juvenile Detention Center, Thurston County will have the juvenile removed within three (3) hours of receiving said notification.

#### III. Default

In the event Thurston County fails to comply with any term or condition of this Agreement, Woodbury County shall give Thurston County notice of said default. Notice of said default shall specify the nature of the claimed default and Thurston County shall have fourteen (14) days after receipt of the said notice to rectify the default.

If Thurston County does not rectify the default within the fourteen (14) days, Woodbury County may terminate this Agreement forthwith. If Thurston County commits the same default within a sixty (60) day period, Woodbury County may terminate this Agreement forthwith with no additional notice to Thurston County.

#### IV. Termination

Woodbury County shall have the option to terminate this Agreement at any time upon thirty (30) day notice to Thurston County. The Agreement may also be amended or terminated at any time upon the written approval of both parties.

Thurston County will have all its juveniles picked up within twenty-four (24) hours of the termination of this Agreement.

#### V. Assignment

This Agreement shall be binding on the parties hereto and neither party shall assign or transfer their interest in this Agreement without the written consent of the other party hereto.

#### VI. Limited Waiver

The failure of Woodbury County to insist on the strict performance of any of the terms and conditions of this Agreement shall be deemed a waiver of the rights and remedies that Woodbury County may have regarding that specific instance only and shall not be deemed a waiver of any subsequent breach or default in any terms and conditions.

#### VII. Indemnification/Hold Harmless

Thurston County shall defend, indemnify, and hold harmless the Woodbury County Juvenile Detention Center and Woodbury County, its officials, employees, and volunteers from any and all claims, injuries, damages, losses, or suits, including attorney's fees, arising or issuing out of or in connection with this Agreement.

#### VIII. Governing Law

This Agreement shall be governed by the laws of the State of Iowa. The venue for any suit shall be Woodbury County, Iowa.

#### IX. Instrument as Entire Agreement

This instrument contains the entire agreement between the parties and no statement, promise, or inducements made by either party that are not contained in this written agreement shall be valid or binding. This Agreement may not be enlarged, modified, or altered except in writing and signed by the parties.

The Board called to order a Wolf Creek Drainage District Trustee meeting.

Motion by Ung second by De Witt to tentatively approve the Engineer's report on annexation for the Wolf Creek Drainage District. Carried 5-0. Copy filed.

Motion by Ung second by Radig to direct the preparation of a Notice of Public Hearing on the annexation report to be mailed to the effected landowners and published in the official newspaper 20 days prior to public hearing date. Carried 5-0. Copy filed.

Motion by Ung second by Pottebaum to set a public hearing date on September 19, 2017 at 5:00 p.m. for review of the report. Carried 5-0. Copy filed.

The Wolf Creek Drainage District meeting was adjourned.

John--Can you help me to forward on to your people? These are some notes I have from our meeting the other day that I hope will prove helpful. If you want to add anything, great. If not, if you could forward on and I'll add any "Reply All" comments, I'd appreciate it.

Jim--I wanted you to have these notes and then we can discuss. I thought of sending this to our committee if you also had a short update on your great idea with Leesa for Artsplash. Finally, what do you think of Tuesday, August 29, Jim, from 2:45-4:00? In the meantime, I could pull together some of this and send onto the committee. Then, I'd like to see if we could meet together perhaps the week before, e.g. Tuesday, August 22, and pull together an agenda. Talking through this together I think will be great ahead of time.

#### Vision for the Tours

1. The group discussed that there are several different venues where technology could help the historic centennial of the courthouse. One idea is to have a virtual tour away from the courthouse for those who are not able to attend, e.g. the 9th grader in Kansas City studying courthouses or the William Steele protege at the U. of Virginia, or the 80-something-year-old relative who would like to attend but cannot from afar. This would be visual and akin to the kind of 3D, "dollhouse view," or navigable points of interest to zoom in and out. That is not the project at hand and is second in priority to this; rather, we are looking at a way for visitors to the courthouse to engage in an audio tour similar to the 6th Floor Museum at Dealey Plaza which artfully combines audio with visual displays, thus the engagement of the Sioux City Museum's Matt Anderson. We agree that the goal is not to detract from what should be the primary focus, namely the majestic courthouse. The only visuals we envision would be displays on the first and second floors and perhaps navigation points, e.g. 1 to hear the audio for 1, 2 to hear the audio for 2, etc. We also recognize that a website is a separate and distinct project from both of the visual, from-afar tour and the on-site audio tour.

#### Navigation

2. We discussed that there is technology that could allow for visitors to discern where they are at in the tour. This would be through I-Beacon technology wherein close proximity gives the cue to the tour. We understand that any temporary displays or tour parts would need the approval and/or input of the committee. Action point: Bob will see what kind of pricing may be available.

We discussed that realistically we would look to have the outside of the courthouse facades and then the first and second floor be as far as people could go. We did discuss if a courtroom could consistently be open but believed that Leesa McNeill could be followed up with to discern if this would be for the May 1-5 time-frame only, or otherwise as well.

#### **Equipment**

3. In order to have this be user-friendly, an I-phone and/or Android app would be great. For those without, Matt Anderson had a device that was once used in yesteryear at the museum that he can bring as an example. We agreed that it would be for in-the-courthouse only usage as we would not want them to "walk away." Therefore, the portion related to discussion outside of the courthouse of the facades may be limited for those smartphone users. Headphones could either be checked out or used individually. Someone would need to man a station or be responsible for equipment accountability. Action point: Matt will see what pricing or if the audio platform is something still available for participants without a smartphone.

#### **Example Platforms**

4. We examined an App called National Park Service Tours by OnCell and Tour Buddy App. Bob/Doug will look into what kind of pricing may be available but would encourage the committee to scroll through and check these out.

#### **Content and Time of Tour**

5. This "working group" does not propose to come up with the content but work with the experts and those passionate, historic-minded citizens who wonderfully have given of their time and talent thus far. However, as a general sketch or outline in order to move the ball downfield, we discussed a 30-minute tour interspersing (in the flavor of some remarkably well done recent sensory experiences) narration, acting, sound effects, reading, etc. to make this "come to life."

For example, 12 "stations" of 2 min, 30 sec each roughly could pace the tour as follows:

- 1. Facade A
- 2. Facade B
- 3. Levi Woodbury, the Old County Courthouse, and the Seat of County Government
- 4. The Story: William Steele's Vision, the Controversy and the Winsomeness of the Local Bricklayers
- 5. 1917: WWI, What Was Happening, and Setting the Scene, Board of Supervisors, etc
- 6. Friezes (aka murals)
- 7. lannelli's Sculptures
- 8. Terra Cotta, Ornamentation, Brickwork
- 9. Courthouse Functions of Yesteryear: The Way We Once Were (Boy Scouts, Sheriff's Quarters, Jail, Monahan Post, Red Cross, etc.)
- 10. Restorations and Light Globes: Refurbishing the Past and Capturing Excellence in the Present (For the Future)
- 11. The Courts: The Judicial Branch of Today and Yesterday
- 12. The Courthouse for the Next 100 Years

Of course, these are all examples and could be a combination of displays featuring the life of an artist and photos but then directing people, "Look up" or hearing music from the period, etc. If done well, this audiovisual could be used for time to come.

We all agree that content will help to drive this.

I truly believe that meeting like this helped to give more form/shape to some ideas and hope that it proves helpful.

#### **EXECUTIVE SUMMARY:**

The current funding of an MOU between the Sioux Rivers Region and the Sioux City Community School District has Sioux Rivers Region fund \$450,600 and the school district at \$30,000 for a total cost of services of \$480,600. It is important to note that this was once a federally funded grant program that expired before Woodbury County (preceding SR Region involvement) began funding at a local level. The awarding of mental health dollars through the levy sees much of this money go to the Sanford Center whose primary purpose involves gang outreach (a noble endeavor, but not a mental health service). It is important to re-examine past practices even before the creation of regionalization. My goal in this is not to rescind current funding for FY 18 but in fairness and with a commitment to excellent, compassionate care to ask the Sioux City Community School District to come back with a recommendation by January 10, 2018 in which two Region members could then interface with them and develop an RFP for such services. Questions of equity, allocating MH dollars for their intended purpose, competition for the appropriate organization, and funding levels can then be addressed. The Region should consider further questions in mind: should the Region for FY 19 continue to fund services at that level, and is there a better delivery model to meet these important needs?

**BACKGROUND**: Sioux Rivers Region has a current MOU agreement from July 1, 2017 through June 30, 2018. The MOU says that "funding continuation and levels of funding after expiration of the agreement shall be reviewed by the Sioux City Community School District and the Region." I believe it incumbent upon us as the Region to start that process now in order to give the Sioux City School District time to communicate their needs and to see at what level we should continue to fund those needs. Important points to keep in mind:

#### Mental Health Funds for the Purpose

1. \$290,600 of the funding goes to the Sanford Center, and \$215,000 goes to the Therapy Services provided by Siouxland Mental Health. Only \$30,000 is contributed by the School District. School districts Sioux City's size typically have At-Risk funding in the neighborhood of \$1.5-\$2.5 million, but the Region has procured 5 outreach specialists funded through the *mental health levy*. Given their primary focus and the argument that they are acting as a referral service—rather than having dedicated backgrounds in mental health—this casts some doubt on the fact that mental health funds are being used for the purposes and promises under which these taxes were collected. A variety of arguments may be offered of how bad things once were or will be without allocating tax dollars to the Sanford Center. However, as noble as those endeavors are, it is incumbent upon us to ask the two-fold questions: are these the purposes under which we collected taxes, and is this then the best delivery for what we are wanting to do?

#### Lack of an RFP Halted Woodbury County Funds to the Sanford Center in the Past and is Necessary Now

2. To date, the Sanford Center has received \$3,508,869.55 since 2006. \$462,301 came from 2013-2015 until County Attorney PJ Jennings halted the practice of allocating direct Woodbury County tax dollars to the Sanford Center when then Executive Director George Boykin oversaw the center's receipt of these funds. Boykin did abstain on both voting for the direct tax allocation as well as MH funds (see Sept 30 of 2008; Sept 1 of 2009; Jun 11 of 2011; Sept 4 of 2014 meetings). Unbeknownst I believe to most Woodbury County taxpayers is the fact that a much larger allocation, \$2,273,840.39, had been expended through mental health services from 2006-2015, and now \$772,728.16 from Sioux Rivers Region since 2016. Those funds from Woodbury County from direct taxation (Gen Basic) were halted because of a lack of an RFP, or a fair process for awarding those dollars, and were then discontinued as a non-mandated service in donating to non-profits starting in 2015 with a new Board of Supervisors. I do not see how this lack of an RFP is dissimilar, nor that the Sioux City Schools have truly been engaged or asked what their needs are.

#### This Funding is a Good Deal of Annual, Ongoing Expenditure that Merits Further "Hard" Data

3. The funding represents an astounding 5% of the annual Sioux Rivers Region budget going to the Sanford Center. Region members want to deliver excellent services and not rubber-stamp what appears admittedly to be a past practice of Woodbury County in its delivery model. It is important to note that the model we are currently invites the kind of oversight and scrutiny that we would give to any other allocation. In fact, I requested nearly a month ago and have just received August 9, 2017 a 23-page report though past documentation should have sufficed rather than this new report. In fact, "appropriate and timely documentation" is spelled out in the MOU.

While the majority of this report contains much that has little to do with MH funding, I have asked the simple question: how many "youngsters" have received mental health services due solely to the outreach specialists? This should be readily available and had documented history since 2001 and been filed with both Woodbury County and then Sioux Rivers Region. I would also like third-party independent verification from the Sioux City Community School District as well as Siouxland Mental Health as referrals are clearly only as good as the number they can provide.

#### The Formulation for Delivery is Inadequate No Matter the Provider

4. The Sioux City Community School District has over 14,000 students, and yet the Sanford Center specialists are located oddly in 5 out of the 21 schools (only 2 out of 3 secondary schools, 2 out of 3 middle schools and 1 elementary school) for reasons that have nothing to do with the best delivery of services. This means that less than 5,000 students would even have access. "A total of 140-150 students receive services each month" is vague, and if it relies on the fairly loose definition of mental health services in the report, I would like to know. Further, are these mental health services? Were they the result of gang prevention outreach specialists whose "primary focus is to work with minority youngsters..." and who work in only 5 out of 21 schools? Is there not a better model in which perhaps if the Region allocated a lesser level of funding—perhaps 75% or \$195,000, that 3 individuals across the west side (West Middle/West High), north side (North Middle/North High), east side (East Middle/East High), and perhaps be a savings to taxpayers or even have students in Sioux County or Plymouth County served additionally?

#### The Solution Can be Reasoned, Thoughtful, Fair, and Measured

5. I am not proposing to pull the rug out from those receiving current funds but to ask the Region to go ahead and send a signal that for planning purposes, we need to take a pause and quite possibly reconsider this portion of funding for FY 19—the level of allocation. With our belt-tightening, something like a 25% reduction may not be in order. However,

at the same time, perhaps an RFP for this service at the very least could be created by giving the District time to discern a better delivery model. The goal would not be simply outreach/referral but could contain identification across a broad spectrum and include working with counselors, juvenile court officers, teachers, and others. Perhaps the number of therapy services and or hours could be increased. Again, I would like to give the SCCSD until the first week of January and then propose that Supervisor Don Kass and myself (Supervisor Jeremy Taylor) meet with the school district cohort to learn their needs and how a future MOU and subsequent RFP could meet those. It will then be up to this Region Board to determine at what level of funding we need to continue and how such agreements will be structured in the future. Of course, the Sanford Center could compete in any such RFP.
