

Permit Provisions and Conditions of Issuance

1. The County and/or the County Board of Supervisors will not be charged with any responsibility for damages to the Applicant's property occasioned by any construction or maintenance operations on said county roads, including new or additional right-of-way acquired in connection therewith, subsequent to the building of the Applicant's facilities. The Applicant shall take all reasonable precaution during the construction of said facilities to protect and safeguard the lives and property of the adjacent property owners and the traveling public and shall save the County and the Board of Supervisors harmless of any damages or losses that may be sustained by adjacent property owners and the traveling public on account of such construction operations.
- 3. Operations in the construction and maintenance of said facilities shall be carried on in such a way as to not interfere with, or interrupt traffic on said roads. However, should the performance of work called for in this permit in any way interfere with or obstruct traffic on said roads, the Applicant shall provide the necessary flagmen as required by the Statutes when one-way traffic is involved and/or otherwise mark said work so as to protect the traveling public.
- 4. The Applicant shall hold the County and the Board of Supervisors harmless from any damages that may result to said highway because of the construction or maintenance of said facilities and shall reimburse the County or the Board of Supervisors for any expenditures that the County or the Board of Supervisors may have to make on said roads on account of replacement of surfacing gravel and bridge and culvert repairs.
- 5. Applicant shall lay, construct, operate and maintain said facilities so as not to interfere with natural drainage of the road and so as not to interfere with the construction or maintenance of said roads. When buried cable or wire lines are to be placed lengthwise with the roadway, they shall be placed in the County road shoulder or ditch near the toe of the fore-slope and parallel to centerline of roadbed at a depth of three (3) to four (4) feet by using specially designed plows or by trenching, whichever is appropriate. Plow slots and trenches shall be repacked as necessary to restore the disturbed area to its original condition. For buried line crossings of roadways not paved, an open trench may be dug and the lines placed therein, and the trench back-filled over the lines. Buried line crossings on paved roadways, lines may be placed through the sub-grade by jacking, or by boring a hole just large enough to take the lines; or if the County Engineer approves, a tunnel may be dug through and the cable or wire lines placed therein. All backfill of tunnels and trenches shall be thoroughly compacted in layers of 6" or less in depth. Back-filling of trenches within the right-of-way by not under the traveled roadway shall be tamped sufficiently to avoid settlement. When crossing an existing roadway, all buried facilities shall be placed a minimum of three (3) to four (4) below the bottom of the existing adjacent ditches. Overhead lines, where practical, shall be placed adjacent to and with two (2) feet of the Road/Highway Right-of-Way Line.
- 6. The Applicant will at any time subsequent to placing the facilities, and at the Applicant's expense, relay, replace, alter, change, reconstruct, or relocate its overhead and/or buried facilities and appurtenances thereto as may become necessary to conform to new grades, alignment, or widening right-of-way, resulting from maintenance or construction operations by the County Board of Supervisors irrespective of whether or not additional right-of-way is acquired in connection with such road improvements. The Applicant agrees to do this within ninety (90) days written notice from the Board of Supervisors, and without cost to the County. If the Applicant is unable to comply within said ninety (90) days, the Board of Supervisors may cause the work to be done and the Applicant will pay the cost thereof upon receipt of statement.
- 7. All work shall be done in a workmanlike manner; the surrounding ground, slopes, and ditch bottoms shall be reshaped to conform to the area and left in a neat condition satisfactory to the County Engineer. All areas where sod has been damaged or destroyed shall be reserved.
- 8. The Applicant shall notify the County Board of Supervisors at least forty-eight (48) hours in advance of the Applicant's intention of starting work covered by this permit on the road right-of-way. Said notice shall be in writing to the County Engineer.
- 9. Applicant, its' successors, grantees and assigns shall and hereby agrees to assume all responsibility, risks and liabilities for all accidents and damages that may occur to persons and/or property on account of the work done under this permit, and to this end, indemnify and hold the County and all authorized representatives thereof harmless from any and all claims, damages, losses, and expense including judgements, costs and including attorney's fees, for personal injuries (including death) or property damage arising or resulting from the activities of the Applicant in connection herewith, now and at all times in the future.
- 10. It is understood that this permit is issued only insofar as Woodbury County has jurisdiction and does not presume to release the Applicant from fulfilling any existing statutes relating to the installation, construction and operation of said facilities.
- 11. It is further understood that the facilities covered by this permit shall be constructed or installed within one (1) year after the date of approval of this permit, unless otherwise extended in writing by Woodbury County.
- 12. Engagement in the operations as herein applied for by the Applicant shall be considered and constitute an acceptance of all the terms and conditions herein set forth.

EXECUTIVE SUMMARY:

At our public outreach meetings, the Board has heard concerns expressed about the quality of our gravel road system. Spring thaw, heavy rain events, and heavier traffic on these county roads has contributed to soft conditions on the roads.

A number of causes can be attributed to the decline in condition of our gravel roads. The primary issues are thinning of the gravel base from 6"-8" in thickness to 2"-4" currently, increasing truck traffic on gravel roads due to increased crop productivity, three severe storm events since 2008 that washed county gravel roads causing further loss of aggregate, and declining replacement of gravel losses due to budget constraints. A 1940s road system built for 40-50 bushel per acre corn is now serving much greater farm productivity with corn crops averaging almost 180 bushels per acre during the past decade (according to USDA statistics). The gravel roads are showing the strain of this increased demand.

The Board has directed staff to make a recommendation for a program to improve the quality of county gravel roads. The County Engineer and Board Financial Analyst have been working on developing a gravel road improvement program, determining its cost, and offering alternatives for how to pay for the project.

BACKGROUND:

County residents have noted and expressed to the Board their concerns about gravel road quality. The perception that county road users have expressed is that the gravel the county is using is not of good quality and that the roads are not being kept in as good of shape as in the past. Residents note that gravel roads are unstable in the spring and sometimes after heavy rains as well.

The secondary road department has worked to address concerns about gravel quality by beginning a quality assurance program where daily samples are obtained during gravel production at the gravel pit. Samples are checked for gradation to assure that it meets county standards. Woodbury County standards for gravel are actually slightly coarser than state and federal recommendations for gravel surfacing (translation: we require a higher quantity of rock than fines than recommended by recognized experts). Financial penalties are included in the program for failure to meet county gradation standards. County staff feels we are seeing a better quality gravel on the road than in the past since the quality assurance program has been instituted.

While gravel quality is improved, the cost of gravel has grown greatly since 2006 resulting in the county purchasing less gravel today than 12 years ago (see accompanying chart) In 2017 the road department spent \$1.4 million for 136,500 tons of stockpiled gravel for use on county roads. In 2003, the county was able to purchase 130,000 tons of gravel for \$640,000. In that 14 year period, the county costs increased but revenue did not increase at the same rate. The county, over the last 14 years has been able to purchase up to 30,000 tons less per year, leaving many roads at a point where they do not receive enough gravel to replace losses.

Senior county road department staff members recalled that until about 30 years ago every county gravel road was regraveled every year with 200-500 tons of material per mile. Over the intervening 30 years since, the gravel replacement program evolved into a gravel stockpiling program where county staff hauled gravel placed at strategic points in the county to roads to cover thin spots rather than resurfacing gravel roads by the mile. Each year as the cost of aggregate increased, less material has been purchased. It is only in the last three years, with the increase in the lowa fuel taxes, that the county begun resurfacing roads again.

FINANCIAL IMPACT:

The cost to add enough gravel to county roads to restore the county gravel base is high and would depend entirely on property taxes. The program we will be discussing will be to provide adequate gravel to add an average of 5 inches of gravel base to each of our 938 miles of gravel roads. This would provide a 7-9 inch gravel base on all roads and greatly increase the reliability of the gravel road system. This is a multi-year program of road improvement.

The estimated costs are as follows:

Gravel production: 2,100,000 tons of gravel produced for 938 miles of county roads. Cost: \$10,000,000 to \$12,500,000.

Haul cost: 2,100,000 tons of gravel hauled to 938 miles of county roads: Cost: \$11,000,000 to \$12,500,000.

Road preparation would be done by county staff using county equipment within the county's current budget and revenue. The proposal to produce and haul the gravel to the roads would be done over a period of 9-10 years. This would give county staff adequate time to reshape and prepare the roads to receive the gravel. Dennis Butler will assist me with showing programs to pay for the cost of this program over a 10 year period.

Tax increment financing is an option for funding this project. The project can also be funded, albeit over a longer period of time, by raising county secondary road property taxes.

There is not adequate growth in road use tax funds or outside fund sources to fund this program.

Less gravel could be applied to the roads, but reduced quantities would result in less overall road reliability.

A less costly program could be reviewed with a subset of roads selected for improvement. Selection criteria could include improving gravel farm to market classified roads, roads with more than 75 to 100 vehicles per day (vpd), and/or improving roads with large livestock operations. Roads having less than 75 vpd would have no changes in their maintenance. Costs for this reduced program have not been calculated at this time.



Background:

In discussions as two supervisors desiring to engage on this issue, we see 4 potential scenarios wherein we can realize the restoration of gravel without imposing an unwished for or increased levy. They are as follows:

1. **Stretch the program over 10 years' time** which is a balanced approach to regaining on 30 years of spot-gravelling and neglect. We did not get there overnight, nor will we be able to restore the condition of 1,250 miles of road overnight.

2. **Utilize new revenue.** This would be the result of increases to CF Industries revenue over a ten-year period past the initial obligations that we will need to meet over the next 3 years. This would give us a bridge from years 4 to 10. The county needs to be careful and judicious with the use of Tax Increment Financing. This is a potential but would need to be carefully vetted as to the impact on taxing bodies. If feasible, utilizing the release of increment and the county's portion may well be preferable. New CF Industries revenue should only be realized and programmed with the intent of the previously passed Taxpayers First Resolution obligating \$1 out of every \$2 of future CF Industries revenue. Also, we must calculate the impact to the secondary roads fund from CF revenue and should show that as a separate line item.

3. Utilize gravel stockpile and internal resources. This should be taken into account in any project as to the defraying of expenses and how much more we can stretch what was done in yesteryear now that we have purchased substantial land resources so as to gain an increased amount of our own gravel.

4. Calculate into the program the increasing weighing of borrowing initially and paying with interest versus the increased costs of production, labor, etc.

5. Consider if rural voters by consensus of several town-hall meetings out in rural areas akin to what was done with the bridge levy would consider adding 50% of what was levied for the special bridge levy, which would generate \$650,000 annually for 10 years, \$6.5 million.

6. Calculate what the potential cost generation of the aforementioned revenues would be over 10 years' time with items 1-5 and separately with/without item 6 to see how we can live within the means and see at what percentage we can make up ground to where we were in yesteryear.

7. Direct the county engineer to prioritize roads based on need, vpd travel, etc.

Funding Options for a Ten Year Gravel Project - Woodbury County 938 Miles of Gravel Roads

Following are several options for a ten year Gravel Project that would reconstruct all 938 miles of County gravel roads.

The following assumptions are: (1) the purchase of 1,000,000 tons of gravel during FY 20 that will be crushed and stockpiled by the County at a cost of\$10,000,000. If the County were to purchase 100,000 tons per year it is estimated the cost would rise 5% per year (% estimated by the County Engineer)

The options are only for purchase and crushing the gravel needed. It does not include the annual cost of hauling and spreading the gravel. That cost will have to be determined each FY in the annual budget.

If the decision is to purchase the all the gravel up front it would be suggested to borrow \$10,000,000 with repayment over 10 years. It is estimated an interest rate of 4%.

The options to be discussed are not in order of preference.

Option #1

The first option would be to fund the Principal and Interest payment of \$1,400,000 from the Debt Service Fund. Based on current taxable valuations the tax rate would increase 29.615 cents per 1,000 which would generate \$1,400,000 in taxes. The repayment would drop each FY by \$40,000 due to interest reductions.

Option #2

Under this option it would be proposed to cover the Principle and Interest payments by the Rural Basic tax rate which would result in a tax rate increase of \$1.22 per 1,000. With this increase the County would still be under the maximum levy allowed by law.

Option #3

Using this option would increase General Basic the tax rate by 8.623 cents county wide which would generate \$400,000 and increase the Rural Basic tax rate 87.509 cents which would generate \$1,000,000.

Option #4

This option involves three different funding sources to achieve the \$1,400,000 payment.

- (1) Use new TIF increment revenue in the amount of \$500,000 each year for ten FY's.
- (2) Use the \$300,000 currently budgeted for gravel each FY.
- (3) Generate \$600,000 from a General Obligation Bond which would result in a tax increase of 1.777 cents which would generate \$84,000 the first FY.

To use TIF revenues the County would have to amend the TIF area for Grow Woodbury County that would include all County Roads and right of ways in Woodbury County.

Option #5

This option has four sources of revenue to make the \$1,400,000 annual payment on the \$10,000,000 General Obligation Bond.

- (1) Use new TIF increment revenue in the amount of \$500,000 each year for ten FY's.
- (2) Use the \$300,000 currently budgeted for gravel each FY.
- (3) Generate \$427,671 from the increase of 10 cents per 1,000 on all taxable property in Woodbury County.
- (4) Generate \$228,547 from a tax rate increase of 20 cents per 1,000 in the Rural Basic Fund on Township only taxable valuations.

To use TIF revenues the County would have to amend the TIF area for Grow Woodbury County that would include all County Roads and right of ways in Woodbury County.

Option #6

This option would involve holding rural meetings similar to the special bridges project to ask the rural citizens to fund a portion or all of the costs and those revenues would be held in a separate fund for the gravel project. It will take up to \$1,400,000 a year for ten years.

All of the options lisited above are only for the gravel and crushing for 1,000,000 tons. This would all be done during FY 20.

The actual cost of hauling and spreading the gravel would come from the annual budget in the Secondary Roads Fund. Funding for this would come from additional revenues during the annual budgeting process starting in January of each year.

EXECUTIVE SUMMARY: Woodbury County has had the honor and privilege of helping sponsor the commissioning of the USS Sioux City. After meeting with Ret. Rear Admiral Frank Thorp, I expressed our appreciation of the crew and to please let them know those sentiments. In the course of our discussion, he said that he would welcome direct communication with the crew and think this is a good opportunity for us to do so.

BACKGROUND: The new USS Sioux City is one of the Navy's newest warships. It was built in Marinette, Wisconsin and is a Littoral Combat Ship (LCS) that will operate in waters close to the shore. The vessel also has a helicopter pad, a ramp for small boats and can be used by small assault forces. While the USS Sioux City is the 11th in the class of fast and versatile Littoral Combat Ships, it is the first time that Sioux City has been honored as a namesake city. Woodbury County had the honor to take part in sponsoring the commissioning of the USS Sioux City (LCS 11). Steeped in tradition, the impressive festivities surrounding the weeklong celebration will inspire everyone who participates through sponsorship as the new combat vessel arrives in Annapolis to be officially commissioned as the USS Sioux City. County participation plays an important role to the Sioux City and Annapolis community supporting the USS Sioux City (LCS 11) Commissioning in a way that will make its crew and our nation proud.

To the Members of the USS Sioux City:

On July 18, it was our privilege to host Retired Navy Rear Admiral Frank Thorp who was an outstanding representative of the USS Sioux City. Admiral Thorp said that he was overwhelmed by the support in the Sioux City community, to which our response was, "We wish that we could do more." We asked him to convey on our county's behalf that all service personnel aboard that craft ought to know that we are behind you.

We were honored to meet some of you as a crew during your last visit and to establish a rich personal connection. Admiral Thorp told one of our supervisors that he would welcome those sentiments being expressed and so we as a Board of Supervisors wanted to collectively do so.

As you may know, Sioux City and Woodbury County have a long and rich tradition of military history. Our airport bears the name of the most highly decorated Soldier living until he passed away in 2017, General Bud Day, whose incredible service spanned amazing feats from World War II to Vietnam. We are also the proud home of the Iowa Air National Guard 185th Air Refueling Wing, the United States 960th Quartermasters Reserve Unit, and the Iowa Army National Guard's 1-113th Calvary Squadron. From those units and others, we send from our families those, like you, who stand in harm's way.

Although we are far from the waters of the coasts, once in a while we also send the Naval Academy one of our own (most recently our Siouxland Chamber president's daughter comes to mind).

We recently celebrated the 100th anniversary of our Woodbury County Courthouse and had rich opportunity to call to mind the sacrifice of service, something less than 1% of the American populace will do in uniform. The designers of our National Landmark courthouse seemed intent on interweaving into the very fabric of the building that the freedom of civil government comes at a price. There are battles that were raging at the time during World War I—Verdun, The Marne, Ypres, The Somme—and they are painted on the walls of our courthouse along with murals of Soldiers and the Red Cross. The first man to die in World War I, 22-year-old Edward Monahan, had the Legion Post housed there with his namesake. We shared with Admiral Thorpe that inside the Woodbury County Courthouse is a plaque made from the hull of the battleship USS Maine which was destroyed in Havana Harbor in 1898. It is as if the founders of courthouse 100 years ago whisper to us today to remember the battles and even the names. In opening up the time capsule this year that they emplaced in 1918, they even held hand-scrawled signatures, veteran lists of those who had fought in the Civil War. In hopes that this ship and your service is not forgotten, we emplaced in our time capsule (to be opened a hundred years from now) the coin of your ship, the USS Sioux City.

Our call, like theirs, is not for the remembrance of a ship, as powerful and impressive as it is: it is a call to remember the crew, all of you who stand upon the deck.

We remember you because we know that the cost of standing upon the deck of the USS Sioux City is in being apart from your families as well in order to keep us safe. We remember you. And if there is one sentiment that we can bear simply in a sentence it is this. Thank you for the sacrifice and the love you display for this country and its people to stand upon waters in our defense. You have put yourself in harm's way but we also recognize that there are moments apart from families—birthdays, graduations, anniversaries, and just being there—those are the day-to-day living of sacrifice. It is not lost on this grateful community the sacrifice that it takes to complete your mission.

Know that just as you all are more than merely a ship, we are more than merely a community. Here in Sioux City and in Woodbury County, there are a people who pray for your protection and safety, your victory in battle as well as peace in your homes.

We desire these words serve as a reminder that we are behind you in the opportunity to encourage you by "holding the ropes," opening our homes to you whenever you next come back, and thanking the Almighty that you stand in support of protecting our freedom. May our God sustain and protect you wherever then your mission takes you until you come safely home.
