




The county paved D53 in 2013 to the K42 intersection. This work was done with county FM funds. While we have been patching the K42 pavement using local funds, the existing pavement is very rough and the existing pavement slabs are faulted in many areas due to heavy loads larger than the 6" pavement was designed to carry. The road receives heavy loads servicing two large dairy operations and serving as a direct haul to the elevator and RR grain loading facility in Sloan.

# WOODBURY COUNTY, IOWA RESOLUTION NO.

#### RESOLUTION APPROVING THE DEFERMENT OF LOAN PAYMENTS

WHEREAS, Woodbury County, Iowa (the "County") has received a formal request from the Correctionville Economic Development Corporation (CEDCORP) to suspend monthly loan payments, which shall include principal, interest, and the total balance due, in the amount of \$56,002.92 (the "Obligation"), until such time that CEDCORP successfully sells the mortgaged asset located at 319 5th Street, Correctionville, IA 51016, or is able to satisfy in-full its Obligation to the County; and

WHEREAS, CEDCORP has been forthright and diligent in their efforts to meet their Obligation with the County as evidenced in the Promissory Note dated April 9, 2013 and the Modification of Promissory Note dated April 18, 2018; and

WHEREAS, upon the occurrence of default and the foreclosure of MacDawn Enterprise, LLC, grantee and mortgagee with CEDCORP, has since created a financial hardship for CEDCORP; and

**WHEREAS**, the County hereby finds and determines that it is a public benefit to and in the best interest of all parties involved to approve the deferment of CECDORP's loan payments due to the County pending sale of the mortgaged asset;

# NOW, THEREFORE, BE IT RESOLVED BY THE WOODBURY COUNTY BOARD OF SUPERVISORS:

- 1. The recitals set forth in the preamble hereof are incorporated herein and shall have the same force and effect as if set forth in this Section.
- 2. The deferment of loan payments, in substantially the form presented at this meeting, is hereby approved.
- 3. The provisions of the Promissory Note will remain in full force and effect. Deferment of the payments due pursuant to this Resolution does not constitute a waiver of the Obligation by the County or limit its right to re-assert any of its rights under the agreement.
- 4. This Resolution shall become effective immediately upon adoption.

For value received, the undersigned, CEDCORP, INC., an IRS 501 (c)(3) non-profit corporation, with principal offices at 1307 Megan's Way, Correctionville, IA 51016, promises to pay to the order of the Woodbury County, Iowa, c/o Dennis Butler, with principal offices at 620 Douglas Street, County Courthouse, Sioux City, IA 51101, or at the holder's option, at such other place as may be designated from time to time by the holder, the sum of One Hundred Twenty-Five Thousand--and--No/100's Dollars (\$125,000.00) with interest thereon from the date first written above at the rate of two percent (2%) per year until paid in full, the first payment of \$1,151.59 to be made on June 1, 2013, to be followed by principal and interest in the sum of \$1,151.59 on the 1st of each month thereafter for 118 months and a final payment of \$1,151.48 to be made on May 1, 2023.

Payment shall be applied first to interest; any balance thereof to be applied on principal. Payment of any installment of principal or interest owing on this Note may be made prior to the maturity date without penalty.

Principal and interest not paid when due shall draw interest at the rate of fifteen percent (15%) per annum.

If default is made in the payment of this Note, or if Debtor fails to perform any covenant, promise or condition of any other Note, obligation or agreement with the holder, or if holder believes itself insecure, the entire principal and accrued interest shall at once become due and payable without notice at the option of the holder of this Note, and thereupon the undersigned agrees to pay all costs of collection, including attorney fees. Failure to exercise these options shall not constitute a waiver of the right to declare the entire principal amount of this Note and interest thereon due and payable at once at any subsequent time.

This Note is secured by all existing and future security interests contained in Security Agreements between the maker(s) and holder, or holder and any endorser, surety or guarantor of this Note, including, but not limited to, that certain Security Agreement dated April 9, 2013, between the maker(s) and holder and payment may be accelerated according to any of them.

1. Modification. The Note is hereby modified to extend the expiration date from May 1, 2023 to May 1, 2028. The current principal balance of the Note is \$66,741.15 and will be re-amortized at 2% for ten (10) years.
