Memorandum of Agreement

Parties

This agreement is between Woodbury County and Tri- State Nursing Occupational Health and Therapy Services 3409 Singing Hills Blvd, Sioux City, Iowa 51106.

1. Term of Agreement

The Term of this Agreement shall commence on August 20, 2025, and shall continue in effect for a period of not less than one year. Thereafter, the Agreement shall continue in full force and effect until canceled by either party at any time, with or without cause, by giving thirty (30) days notice to the other. This Agreement may be amended from time to time by mutual consent, in order to reflect the current status for the need of drug and breath alcohol (DAS).

2. Legislative Limitations

In the event any third-party payer, or any other Federal, State or local law, rules, regulations, or interpretations at any time change the method or amount of reimbursement or payment for services under this Agreement, then the parties agree to negotiate in good faith to amend this Agreement. If this Agreement is not amended prior to the effective date of such rule, regulation or interpretation, this Agreement shall terminate as of such effective date.

3. Description of Services

- A. Tri-State Nursing Occupational Health and Therapy Services shall upon request of Woodbury County assign DAS personnel to Woodbury County for the purpose of DAS collections. Tri- State Nursing Occupational Health and Therapy Services shall train all collectors assigned to Woodbury County and provide documentation of said training in the collector's personnel file.
- B. Tri- State Nursing Occupational Health and Therapy Services stands by its performance. If services are not satisfactory or difficulties should arise, the parties agree to expend reasonably good faith efforts to resolve any problems.

4. Status of Nursing Service and Insurance Coverage

A. Tri- State Nursing Occupational Health and Therapy Services is performing hereunder as an independent contractor and not as an employee, agent, partner, or a joint venture with Woodbury County. All collectors assigned to Woodbury County pursuant to this agreement shall be considered employees of Tri- State Nursing Occupational Health and Therapy Services only. Tri- State Nursing Occupational Health and Therapy Services shall assume sole and exclusive responsibility for the payment of wages to collectors for services performed by them at Woodbury County. Tri- State Nursing Occupational Health and Therapy Services shall, with respect to said collectors, be responsible for



payment of all federal and state withholding taxes applicable to insurance obligations, and other applicable taxes and contributions. Tri- State Nursing Occupational Health and Therapy Services shall provide general and professional liability limit of not less than \$1 (one) million dollars per occurrence. Woodbury County retains professional and administrative responsibility for services rendered. All employees of Tri- State Nursing Occupational Health and Therapy Services will be covered by Worker's Compensation.

B. Tri- State Nursing Occupational Health and Therapy Services warrants that it is in compliance with all State and Federal laws applicable to the employment of collectors who are assigned by it to Woodbury County.

5. Documentation

- A. Upon written request, Tri- State Nursing Occupational Health and Therapy Services provides Woodbury County with documentation in a form satisfactory to Woodbury County, which establishes evidence of the following:
 - 1. Worker's Compensation
 - 2. General and professional liability insurance
 - 3. Tri- State Nursing Occupational Health and Therapy Services State and Federal employee identification number
 - 4. Certificate of Compliance for state and federal contribution requirements
 - 5. Statement that Tri- State Nursing Occupational Health and Therapy Services conforms to the Fair Labor Standards Act
 - 6. Employee compliance as applicable

6. Qualifications of DAS Collection Personnel

- A. Each collector assigned to Woodbury County by Tri- State Nursing Occupational Health and Therapy Services shall be qualified for the position of DAS collections.
- B. Completed training at Tri- State Nursing Occupational Health and Therapy Services for the purpose of DAS collections.

7. Definition of Responsibility

- A. Woodbury County shall be responsible for orientation to the process for identification to reach the responsible nurse or supervisor when collector is called in for DAS, patient identification system, location and activation of fire alarms and other patient safety systems such as infection control programs and manner of reporting unusual incidents or injuries.
- B. All scheduling is to be done through Tri- State Nursing Occupational Health and Therapy Services. When the need for an on-call DAS collection arises, Woodbury County designee will contact Tri- State Nursing Occupational Health and Therapy Services by calling 712-202-0702 or 1-800-727-1912. The Tri- State Nursing Occupational Health and Therapy Services representative will send the collector to Woodbury County. The



collector will arrive at Woodbury County within 2 hours of initial call being received by Tri- State Nursing Occupational Health and Therapy Services.

8. Accessibility

Tri- State Nursing Occupational Health and Therapy Services office is open from 8:00am to 5:00pm, Monday through Friday. After regular office hours, telephones are forwarded to an answering service and messages are forwarded to a Tri- State Nursing Occupational Health and Therapy Services. After hours calls will be returned with reasonable promptness.

9. Billing Procedures

A. Tri- State Nursing Occupational Health and Therapy Services employees will record hours worked at Woodbury County on individual time slips. Employees will ask the supervisor or charge person to sign their time slip to confirm hours worked as indicated. The time slip and the collectors copy for the DAS collection shall be the sole basis for the billing of charges.

Tri- State Nursing Occupational Health and Therapy Services invoices will indicate the employee's name, date, job class, hours worked, and billing rate.

Tri- State Nursing Occupational Health and Therapy Services invoices are mailed monthly and are payable within 30 days. Payment in a timely manner is expected on all invoices requiring approval. Services will be suspended when an invoice has reached 30 days or more past due.

B. Fee Schedule: Rates indicated shall be effective for a minimum of 1 (one) year. Each new rate schedule adopted by the parties shall be in effect for a minimum of 1 (one) year. Tri- State Nursing Occupational Health and Therapy Services will give Woodbury County a 30-day notice prior to increase in rates.

10. Indemnification

A. Tri- State Nursing Occupational Health and Therapy Services agrees to indemnify and hold harmless Woodbury County its agents, officers, directors, employees, detainees and other independent contractors from any and all claims, demands, losses, fees, causes of action, costs damages, and other expenses of any kind whatsoever, including attorney fees that any person or entity should claim against Woodbury County resulting from or arising in connection with any action or failure to act of any Tri- State Nursing Occupational Health and Therapy Services employee or breach by Tri- State Nursing Occupational Health and Therapy Services of any provision of this agreement, violation of any statute, rule or regulation, done in an intentional, reckless or negligent manner.



- B. Woodbury County agrees to indemnify and hold harmless, to the extent permitted by law, Tri- State Nursing Occupational Health and Therapy Services, its agents, officers, directors, employees, and other independent contractors from all claims, demands, losses, fees, causes of action, costs damages, and expenses of any kind whatsoever, including attorney fees, that any person or entity should claim against Tri- State Nursing Occupational Health and Therapy Services resulting from or arising in connection with any action or failure of any Woodbury County employee or breach by Woodbury County of any provision on this agreement, violation of any statute, rule or regulation, done in an intentional, reckless or negligent manner.
- C. Tri- State Nursing Occupational Health and Therapy Services shall also indemnify Woodbury County against all liability and loss in connection with its failure to comply with its obligation to pay all federal, state and local taxes or contributions imposed or required under unemployment insurance, social security and income tax law, and worker's compensation with respect to Tri- State Nursing Occupational Health and Therapy Services employees engaged in performance of the Agreement.

11. Modification of Agreement

Any modification of this agreement or additional obligation assumed by either party in connection with this agreement shall be binding only if evidenced in writing signed by each party or an authorized representative of each party.

12. Effect of Partial Invalidity

The invalidity of any portion of this agreement will not and shall not be deemed to affect the validity of any other provision. In the event that any provision of this agreement is held to be invalid, the parties agree that the remaining provisions shall be deemed to be in full force and effect as if they had been executed by both parties subsequent to the expungement of the invalid provision.

13. Addendum's

Addenda or attachments may be mailed to Woodbury County at any time during this agreement, such as permanent placement if the need should arise. Any such addendum's becomes part of the Agreement.

14. No Waiver

The failure of either party of this Agreement to insist upon the performance of any of the terms and conditions of this Agreement, or the waiver of any breach of any of the terms and conditions, but the same shall continue and remain in full force and effect as if no such forbearance of waiver had occurred.
