This event will be held at Southwood Conservation Area located Southwest of Smithland, Iowa at 3399 330th St. from 10:00 am to 1:00 pm. All youth are invited to attend, and this will be open to the first 60 registered. Youth will be fishing from the shore with deputies and officers.

This event is being organized with the goal of bringing local law enforcement and our area youth together, using fishing as a way of making a connection. Involvement in outdoor activities such as fishing has been shown to reduce the likelihood that children will become involved in criminal activity.

Children 7 years old or younger must be accompanied by an adult for the duration of the event. We encourage parents to partake in the event with their children and take the opportunity to interact with some of our local law enforcement officers.
