As this panel contemplates your significant responsibility and obligation to fill the vacancy on the Woodbury County Board of Supervisors, I am respectfully requesting your consideration of my application to fulfill the approximately two years remaining of this term.

Over the past several weeks, I have heard from Woodbury County citizens about the need to bring an additional voice with increased perspective and balance, experience, and fiscal discipline to the Board of Supervisors. Considering these critically important qualities, I believe that I am uniquely qualified and, after twenty-five (25) years of professional service to Siouxland and two months of attending various County meetings, also properly prepared to fill this role. I am capable of doing so with a limited learning curve, which would allow me, if selected, to hit the ground running.

First and foremost, addressing the apparent desire from voters for perspective and balance, it has become quite clear to me that Woodbury County citizens are seeking a Supervisor with a broad personal and professional insight capable of bringing additional balance to this body. My personal outlook is informed by a lifetime of rural living. A Siouxland native, I grew up in the country where my family raised cattle, practiced and competed in rodeo at the state and national level, and ran a refrigerated long-haul trucking company. My work ethic was formed at an early age with a long list of daily chores, twice daily roping practice, and a rigorous academic schedule at school. After graduating from Heelan High School, I earned a degree in Business Marketing from Iowa State University and worked for two years in California and Arizona in the management trainee program for Payless Cashways before returning to Iowa to join the family business, where I worked in the trucking industry for a decade. Subsequent to this, I transitioned to serve in a marketing capacity at the Sioux Gateway Airport. Over the course of my career, I was consistently entrusted with additional responsibilities, including economic development, regional transportation, government relations, and community enhancement initiatives throughout our community.

My husband and I chose to raise our family on an acreage in rural Woodbury County and are the parents of two adult children. We built our home on a gravel road east of Sioux City and have never regretted that decision. While our two children left Siouxland to pursue their college educations, after earning their degrees, both elected to return to their hometown to pursue their professional careers in education and engineering, respectively.

My schedule now affords me the time to focus on public service and after countless conversations regarding this vacancy, I am convinced that my rural roots, coupled with my work

in the Siouxland business community, will bring a beneficial viewpoint to the Board of Supervisors. Furthermore, my selection and service would bring a historically and currently underrepresented frame of reference to the Board.

Secondly, I am confident that my professional experience is well-suited to serve the people of Woodbury County. With over two decades of professional business experience in Siouxland, my background will complement the current composition of this Board. It is important to note that I helped negotiate the single largest economic development project in the history of Woodbury County at CF Industries. I also participated in the confidential discussions that resulted in multiple expansions at AGP totaling nearly \$200 million. Collectively, my direct involvement in these economic development opportunities in rural Woodbury County represent nearly \$3 billion in capital investment, and I am enormously proud of my role in growing Woodbury County's employment, investment, and tax base. In addition, for over a decade, I have been directly involved in the effort to add an interchange on Interstate 29 near Port Neal. While few are aware of this fact, I also helped resurrect and lead the Siouxland Expo Center project at the former John Morrell site which has been a tremendous addition to our tri-state community.

Finally, as Woodbury County works to maintain the same level of financial discipline our taxpayers have come to expect in the allocation of their hard-earned dollars, I bring a history of fiscal responsibility that has long been among the hallmarks of my tenure of service in both my public and private sector roles and responsibilities.

As you finalize your decision to fill the current vacancy on the Board of Supervisors, I genuinely hope that the perspective and balance, experience, and fiscal discipline reflected in my background will compel you to select me to serve in this important role.
