I grew up on a family farm in rural Woodbury County, and currently I am the 3rd generation to live on that same acreage. The 16 acres I still own are used as a hobby farm for our horses, chickens and goats. My children used these as 4H projects at the Woodbury County Fair and the animals are now enjoying their retirement. I have lived in rural Woodbury County for most of my life and enjoy using the county parks for camping and hiking and, as a kayaker, I enjoy the waterway access points that are available on the Little Sioux. I think, as a rural resident, I could bring a fresh perspective to the Board of Supervisors offering a unique look at the issues presented by living in the rural part of the county. I take great pride in always giving 100% to every project I take on. Through my years working with a local government, I have learned the importance of researching every issue that is presented to not only learn history as to why it has been presented, but also what issues could arise in the future with a policy change. I am currently employed as a City Clerk for the cities of Pierson and Quimby. I have 16 years of experience with government budgets and accounting. I have knowledge of the tax levies, roll backs and assessments and I know that I could step into this position during the budget season with good understanding of the process and knowledge of each of the county departments. During my time working with municipalities, I have:

Prepared and directed development of all department's budgets, goal, and objectives. Most recently working with a \$70,000 deficit in the City of Quimby from a former clerk that did not have a good understanding of the budget process. I have prepared a path forward to help that city move toward a positive balance.

 Rehabilitation Grant program.

- Worked with FEMA on disaster declarations and funding.
- Maintained public records and handled open records requests to support transparency in our local gov't.

- Prepared Ordinances, Resolutions, Agendas, recorded minutes and publicized information required by law to facilitate city council meetings.

- Created a Source Water Protection Plan along with designing a native plant area over and around our municipal well to help alleviate nitrate issues.

- Worked with an engineer firm to develop a Capital Improvement Plan and a Comprehensive Plan.

 includes sampling water/waste water, filing all tests and reports, and maintaining

- Utility budget preparation for new requirements to ensure funding is available for the future.
- Worked with the Census promoting the importance of the process to make sure we had everyone counted to ensure our future per capita funding.
- Assist the volunteer Fireman Association with finances.

Prior to City employment I worked for Greenberg Jewelers, and Tyson Foods in their accounting departments preforming the following duties: Followed up with vendors, managers, and other employees to resolve open issues and discrepancies. Coded and processed accurate invoices to obtain timely payments. Researched payment issues and outstanding checks. Coded and entered invoice data to accurately track invoice status and payments rendered. Processed daily invoices and payments to keep accounting records current.

In closing I would like to reiterate the fact that the rural area is not very well represented by the Board of Supervisors and would welcome the chance to provide a new perspective to the position.

council people left, they were unable to hire or make decisions until after a special election. As
the only employee left, I dug in and was able to obtain my water and wastewater license from the
Iowa DNR to keep the town in compliance. I also moved the parks and cemetery that summer
until we were able to hire a new public works employee. While this doesn't specifically pertain to the Board job, it does show that I am a dedicated employee that is willing to go the extra mile
for whatever task is in front of me. I always look forward to learning new skills and taking on
challenges. I am constantly researching and thinking outside the box. Through conversations and
expressing my reluctance to spend millions of dollars on wastewater upgrades in Pierson, the
University of Iowa/BES contacted me on a pilot project proposal that could save the town approx
3 million dollars and keep us in compliance with permit regulations.
